

Addendum to Agenda Item 7 of the Meeting of the River Hamble Harbour Board on Friday 12 January 2018

- 4.65. 07 Dec. Patrol conducted mooring and pontoon checks. Replaced a fender on a mid-stream moored yacht. Replaced a parted stern line on another mid-stream moored yacht. Freed a trapped line on a mid stream pontoon.
- 4.66. 08 Dec. Patrol conducted mooring and pontoon checks. Responded to a call from a member of the public about a yacht aground just outside the River. Yacht abandoned on a lee shore. Liaison with HM Coast Guard and Southampton Harbour Master to contact the owner.
- 4.67. 09 Dec. Patrol conducted mooring and pontoon checks. Recovery of yacht at 4.66 in company with Hamble Lifeboat. Hull inspection and tow to Warsash jetty pending recovery by owner.
- 4.68. 10 Dec. Patrol conducted mooring and pontoon checks. Owner of yacht at 4.66 paid for tow and mooring and made arrangements for the yacht's recovery.
- 4.69. 11 Dec. Patrol conducted mooring and pontoon checks. Towed two yachts back to their proper mooring following completion of planned maintenance work.
- 4.70. 12 Dec. Patrol conducted mooring and pontoon checks. Routine Marina liaison visit. Nothing significant to report.
- 4.71. 13 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.72. 14 Dec. Patrol conducted mooring and pontoon checks. Monitoring of bait digging near Crableck. Routine maintenance on HYDRA.
- 4.73. 15 Dec. Patrol conducted mooring and pontoon checks. Responded to a call from a River User regarding a submerged mooring. Mooring correct on arrival.
- 4.74. 16 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.75. 17 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.76. 18 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.77. 19 Dec. Patrol conducted mooring and pontoon checks. Responded to a report from HM Coast Guard that a life raft had been seen adrift off Netley – passed to Southampton Harbour Master for immediate action. Life raft abandoned – recovered.

- 4.78. 20 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.79. 21 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.80. 22 Dec. Patrol conducted mooring and pontoon checks. Defect rectification on ROSE (faulty guage). Gave First Aid to a member of the public who had slipped outside the Rising Sun public house. Ambulance called and injured party checked for further injury.
- 4.91. 23 Dec. Patrol conducted mooring and pontoon checks. Responded to a call from Hamble Lifeboat regarding a possible oil spill near the mouth of the River. On inspection, a light film of diesel was seen and broken up by propeller wash. Source of spill investigated but not found. Liaison with Hampshire Constabulary regarding a stolen fuel canister. Liaison with Hamble Life Boat regarding New Year charity raft race. Liaison with a Marina regarding a yacht taking on water. Marina unaware and yacht removed from the water. Owner contacted.
- 4.92. 24 Dec. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.93. 25 Dec. Office closed as advertised. On call. Nothing significant to report.
- 4.94. 26 Dec. Patrol conducted mooring and pontoon checks. Responded to report of a minor berthing collision of a yacht with a moored vessel. Owners placed in contact. Re-fixed a loose stern line on a moored yacht.
- 4.95. 27 Dec. Patrol conducted mooring and pontoon checks. Conducted a search for a kayak adrift from a boatyard. Not located.
- 4.96. 28 Dec. Patrol conducted mooring and pontoon checks. Routine liaison with the Crown Estate mooring contractor regarding forthcoming planned pile maintenance work. Seasonal clean of tide gauges. Recovered a kayak reported lost on the HM Facebook site and made contact with the owner.
- 4.97. 29 Dec. Patrol conducted mooring and pontoon checks. Very strong local winds (51 knots recorded) for a period 0800-0805, then light airs. Checked for chafing on boats secured to the Warsash Harbour Master's Jetty. Fielded calls from owners reporting collisions while berthing. Recovered a set of large embarkation steps from the River at Warsash belonging to a Marina. marina to collect. Replaced fenders on a number of moored yachts. Reported inundation of a number of moored tenders to their owners. Reported a torn sail cover to the vessel's owner.
- 4.98. 30 Dec. Patrol conducted enhanced mooring and pontoon checks following strong winds of 29 Dec. Refitted a sail cover on a yacht moored at Bursledon.
- 4.99. 31 Dec. Patrol conducted mooring and pontoon checks. Refitted stern lines on two mid-stream moored yachts (parted). Owners informed. Recovered a large cushion and a set of steps from the River at Warsash.

- 4.100. 01 Jan. Patrol conducted mooring and pontoon checks. Support to the annual New Year's Day charity Raft Race. Recovered an inundated tender from the 'H' run to Warsash. Pumped out and attempted to contact owner.
- 4.101. 02 Jan. Patrol conducted mooring and pontoon checks. Nothing significant to report.
- 4.102. 03 Jan. Patrol conducted mooring and pontoon checks. Liaison between a mid-stream mooring holder and Hampshire Constabulary regarding a break-in and theft of marine electronics.
- 4.103. 04 Jan. Patrol conducted mooring and pontoon checks. High (120% Springs) tide exacerbated by the effect of Storm Eleanor leading to localised flooding around the River.
- 4.104. 05 Jan. Patrol conducted mooring and pontoon checks. Recovery of a yacht awning from the River near Port Hamble.
- 4.105. 06 Jan. Patrol conducted mooring and pontoon checks. Supported a wildfowl survey. Liaison with a sailing club regarding safety boat navigation.
- 4.106. 07 Jan. Patrol conducted mooring and pontoon checks. Re-secured two yachts with loose moorings towards the Bursledon bend. Liaison with Hamble Lifeboat regarding a River Hamble vessel beached at Calshot. All persons recovered. Recovered a polystyrene float from the mouth of the River. Liaison with a sailing club to accommodate dinghy sailing off Lobster Quay.
- 4.107. 08 Jan. Patrol conducted mooring and pontoon checks. Clearance of shore storm debris at Warsash with Fareham Borough Council.
- 4.108. 09 Jan. Patrol conducted mooring and pontoon checks. Liaison with emergency services in recovery of a man from the River near No 5 beacon. The casualty had walked into the River voluntarily. First aid administered at the Harbour Office pending arrival of Hampshire Ambulance.
- 4.109. 10 Jan. Patrol conducted mooring and pontoon checks. Pile checks prior to the forthcoming Crown Estate maintenance programme. Hosted routine IFCA meeting with local fishermen.
