## 1. The Decision:

- a) That approval be given to acquire all third party interests in land, and any necessary rights, required for or to facilitate or enable the delivery of the proposed Botley Bypass (the Scheme), on detailed terms and conditions to be settled by the Director of Culture, Communities and Business Services (Strategic Manager Assets and Development).
- b) That, in order to ensure the delivery of the major highway scheme in a timely manner, authority be given to the making of a compulsory purchase order as soon as possible to run in parallel with negotiations to preferably acquire all third party interests in land and any necessary rights by agreement.
- c) That delegated authority be given to the Director of Culture, Communities and Business Services (Strategic Manager Assets and Development) to amend the scope of land required for the delivery of the Scheme, as shown on the appended plans, on the basis that it will not be extended but could be revised or minimised.
- d) That authority be delegated to the Director of Economy, Transport and Environment and the Head of Legal Services to progress any appropriate Orders, Notices and Statutory procedures and obtain any consents, rights or easements that are necessary for the Scheme.
- e) That, at the relevant time, the County Council's existing landholdings required for the Scheme be appropriated from County Farms purposes to Transportation (Highways) purposes.

### 2. Reason for the decision:

2.1. The decisions are necessary in order to authorise the acquisition of all third party interests in land required for delivery of the Scheme, and enable the Scheme to be delivered in a timely manner.

# b. PART TWO - Invest in Hampshire Funding

- i. That a sum of £21,500 be approved from the Invest in Hampshire fund to the Hampshire Music Service (HMS) towards the cost of their performance at the Royal Albert Hall on 23 April 2018.
- ii. That, in addition to the above funding to HMS, it be agreed to underwrite the cost of the performance and that the Director of Corporate Resources be given delegated authority to agree the final sum to be paid, should any shortfall be identified.
- iii. That a sum of £6,000 be awarded from the Invest in Hampshire fund towards the cost of contributing to a commemorative album to mark the RAF's Centenary.

### 2. Reasons for the decisions:

- 2.1. The awarding of these funds would support the County Council's Corporate Priorities of making Hampshire safer and secure for all, maximising well-being and enhancing our quality of place for residents of Hampshire.
- 2.2. At the Decision Day, a further request for financial assistance from the Invest in Hampshire fund was considered towards the cost of contributing to a commemorative album to mark the RAF's Centenary.
- 2.3. The County Council had been approached to contribute to the book as a Patron by way of a profile within the album, showcasing the organisation's history, values, work and vision for the future in terms of support to the armed forces and the RAF in particular. Contributing to the publication will promote the work the County Council does with and in support of the armed forces and support the RAF100 Appeal charity. It will also provide an opportunity to highlight the County Council's responsibilities under the Armed Forces Covenant, which is a promise from the nation to those who serve or have served in the armed forces, and their families, that they are treated fairly.
- 2.4. In considering the request, it was noted that production of the album was due to begin in February/March and because of this time factor, it was agreed to consider this request at the Decision Day today rather than wait until the next one scheduled in March. After detailed discussion, it was agreed to award a sum of £6,000 from the Invest in Hampshire fund.
