#### 1. Recommendations:

- 1.1. To award the Hampshire Cultural Trust a grant of £400,000 from the Investing in Hampshire fund towards the development of a cultural hub in the Old Grammar School building, Gosport, as outlined in Appendix 2 of this report.
- 1.2. To approve an award of £10,000 for the New Forest and Hampshire County Show from the Investing in Hampshire Fund as outlined in Appendix 3.

#### 2. Executive Summary

- 2.1. The purpose of this report is to seek approval to two contributions from the Investing in Hampshire Fund towards the Hampshire Cultural Trusts' project to create a Cultural hub in the Old Grammar School building, Gosport and to support the New Forest Show.

#### 3. Hampshire Cultural Trust – Old Grammar School Gosport

- 3.1. The Hampshire Cultural Trust are an independent Trust who manage, operate and develop the County Council's cultural assets and offers.
- 3.2. The Old Grammar School, Gosport is a listed building of great local significance located in Gosport Town Centre and is owned by the County Council. The building is currently poorly utilised and in need of refurbishment. The proposed project would create a sustainable local use. The building is very close to the Council's Discovery Centre and the proposed Cultural Hub would complement the facilities and services provided in the Discovery Centre.

- 3.3. Gosport Town has a negative socio-economic profile and of the 35 lower output areas in Gosport 20 are in the most deprived nationally in terms of education, skills and training.
- 3.4. As an important and valued part of Hampshire the County Council has actively invested in the Borough to support initiatives that address this context. This project represents further commitment, in partnership with others, to draw in external investment to support the town.
- 3.5. The overall project cost is £1.950m plus fees of £150,000. The Trust plans to raise the bulk of the funding through external grant funding applications including to the Heritage Lottery and Arts Council. This will see external investment of £1.4m coming into Gosport in support of the project. The Trust itself will contribute £200,000 and Gosport Borough Council have already confirmed their match funding contributions.
- 3.6. On completion of the project, the building would be leased to the Trust saving the Council at least £40,000 of operating costs a year.

#### **4. New Forest and Hampshire County Show**

- 4.1. 2018 marks the 98th year since the establishment of the New Forest Agricultural Show Society – a registered charity and organisers of the New Forest Show.
- 4.2. The show attracts over 98,000 visitors across the three days and is rated among the top ten agricultural shows in the country. This year the show is increasing the number of interactive and ‘hands on’ activities and displays across the showground to engage and educate children and families.
- 4.3. The show is also an important and well established Hampshire event which makes a positive contribution to the rural and farming economy – promoting and encouraging the development of agriculture, forestry, equestrianism and horticulture, and the improvement in the breeding of livestock.
- 4.4. The County Council will be represented at the show to inform and advise residents about a wide range of services including Connect 2 Support Hampshire, Shared Lives, Falls Prevention, Reablement, Public Health, Waste Prevention, Road Safety, Outdoor Centres, Fostering & Adoption, Libraries and HC3S.
- 4.5. A request has been made to the Investing in Hampshire fund for £10,000 to help meet the running costs of the show and to reflect the County Council’s wider representation at the event.

## FUNDING CRITERIA FOR INVESTING IN HAMPSHIRE

The following criteria should be taken into account when considering a request for funding.

1. Assistance will be considered only in response to direct applications from properly constituted organisations seeking assistance. The application must show that the organisation is properly and legally organised and has its own bank account. Funding would only be awarded if the proposal was to support activity within agreed County Council priorities.
2. Applications will only be considered for specific capital projects for the improvement or maintenance of significant assets or facilities within Hampshire, within agreed priorities and where other substantial funding exists.
3. The wider economic benefits to the residents of Hampshire should be considered together with any complementary benefits for Hampshire County Council. Awards would normally only be given to projects within the remit of Policy and Resources.
4. Awards will not usually be made in respect of applications from the following:-
  - Government Institutions
  - Schools
  - Overseas and out of County organisations which have no direct Hampshire involvement
  - Bodies requesting funds for onward distribution to other charities e.g. mayoral appeals, carnivals, fetes, or for their own fundraising events.
5. Apart from exceptional circumstances, the requesting body would be expected to provide their own funding towards the project.
6. As a general rule, grants in excess of £100,000 will not be awarded unless significant benefits and funding are available. In exceptional cases, where the benefits are significant and directly relate to services and functions close to the County Council's key objectives, then an award greater than the level above would be considered.
7. Given the longer term nature of capital projects, requests can be considered well in advance, but funding will only be released once evidence of capital expenditure has been provided to the County Council or other arrangements made consistent with the agreement of the Director of Corporate Resources

The Library no longer requires the use of the building and no other sustainable alternative use has been identified. Upon completion of the project, the proposal is to lease the building to the Cultural Trust which would save operating costs of at least £40,000 a year. The project would complement the use of the close-by Gosport Discovery Centre which has just re-opened following refurbishment.</p>
<p>Any other relevant factors?</p>	<p>The HLF application is to be submitted before 31 August this year. The application to the Big Lottery fund will be made by Gosport Borough Council in 2019/20.</p>
