## Purpose of the report

 The purpose of this Report is for the Executive Member to consider the recommendation from the Health and Adult Social Care Select Committee on 14 March 2019 and to reconsider her decision taken on 27 February 2019 (the Original Decision) as set out in paragraph 1.2 of the decision record in Annexe 1 of Appendix 1 (the Decision).

#### Recommendation(s)

 That the Executive Member for Adult Social Care and Health confirm the decision made on 27 February that further work is undertaken prior to any decision being made, as to all possible wider options and that further reports will be submitted not before autumn 2019 to the relevant Executive Member/s for consideration.

## **Contextual information**

3. At the Call-In meeting of the Health and Adult Social Care Select Committee on 14 March 2019, The Committee considered the Report attached in Appendix 1. The Committee voted to refer the Original Decision back to the Executive Member for reconsideration (carried with 13 in favour and 1 against). The Committee also agreed the following wording as explanation for why they recommended the decision be reconsidered:

'The Committee thanks the carers for their dignified and informed deputations and recognises the value of Orchard Close. The Select Committee urges the Executive Member, in the strongest possible terms, to rule out closure of Orchard Close as an option'

4. During the debate at the Call-In meeting, Members noted that the service users and carers who had made deputations had expressed that the Original Decision created stress for them, as it created uncertainty about the future of Orchard

Close until the autumn at the earliest. Committee Members took onboard this impact, and in their comments during the debate indicated that this influenced their decision to vote to ask the Executive Member to reconsider. Committee Members commented that it would be preferable to provide clarity to the service users and staff about the future of Orchard Close respite service. Committee Members commented that it would be their preference to find the required savings another way and keep Orchard Close open.

5. When reconsidering her decision, the Executive Member will recall that it is not possible to take a decision which fetters the professional discretion of Officers to perform their professional roles, or which fetters the discretion of the County Council to take action in future. This advice was given to the HASC on 14 March in paragraph 6.3 in Appendix 1.

## Conclusion

6. That the Executive Member for Adult Social Care and Health is therefore asked to reconsider the Original Decision.
