PUBLIC PATH EXTINGUISHMENT AND
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2016**

On 28 February 2017, Hampshire County Council confirmed the above named Order, made under Section 118 of the Highways Act 1980.

The effect of the Order as confirmed is to extinguish the public footpaths running from SU 7277 4054 to SU 7281 4060 (A-B on the Order map), from SU 7289 4074 to SU 7287 4090 (C-D-E-F on the Order map), and from SU 7288 4088 to SU 7288 4090 (E-G on the Order map), as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at the offices of Hampshire County Council, The Castle, Winchester, SO23 8UJ and at the office of East Hampshire District Council, Penns Place, Petersfield, GU31 4EX at all reasonable hours, or online at <http://www.hants.gov.uk/publicnotices>. Copies of the Order and the map may be bought from me at a price of £4.00.

The Order comes into force on 28 February 2017, but if any person aggrieved by the Order wants to question its validity, or any provision contained in it, on the grounds that it is not within the powers of the Highways Act 1980, as amended, or on the grounds that any requirement of the Act, as amended, or any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from 3 March 2017 make application to the High Court.

This Order is made by Hampshire County Council (“the authority”) under Section 118 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that the part of the footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Hampshire Definitive Map and Statement of Public Rights of Way (dated 15th December 2007) require modification in consequence of the occurrence of an event specified in section 53(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this order) of a highway hitherto shown or required to be shown in the map and statement.

East Hampshire District Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Alton and shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be extinguished after 42 days from the date of confirmation of this Order, and thereupon the Hampshire Definitive Map and Statement of Public Rights of Way (dated 15th December 2007) shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in the Schedule to this Order.
2. Notwithstanding this Order all Statutory Undertakers shall have the same rights over the land referred to in paragraph 1 as they have hitherto enjoyed.

PART 1

DESCRIPTION OF PATHS OR WAYS TO BE EXTINGUISHED

From SU 7277 4054 to SU 7281 4060

That part of Footpath 29a in the Parish of Alton in the District of East Hampshire that commences at a junction with Footpath 30 (Point A on the order plan), and proceeds in a north-easterly direction to a point on Eggar's School play courts at Point B.

A total length of 73 metres.

From SU 7289 4074 to SU 7287 4090

That part of Footpath 29b in the Parish of Alton in the District of East Hampshire that commences adjacent to 12 Complins at the boundary of Eggar's School playing fields (Point C) and proceeds in a north-easterly, then north-westerly direction via Point D and through Point E to a junction with another section of Footpath 29b at Point F.

A total length of 212 metres.

From SU 7288 4088 to SU 7288 4090

That part of Footpath 29b in the Parish of Alton in the District of East Hampshire that commences at a junction with another section of Footpath 29b at Point E and proceeds in a northerly direction to a junction with another section of Footpath 29b at Point G.

A total length of 21 metres.

Add: "That part of the path which ran between SU 7277 4054 and SU 7281 4060 has been extinguished."

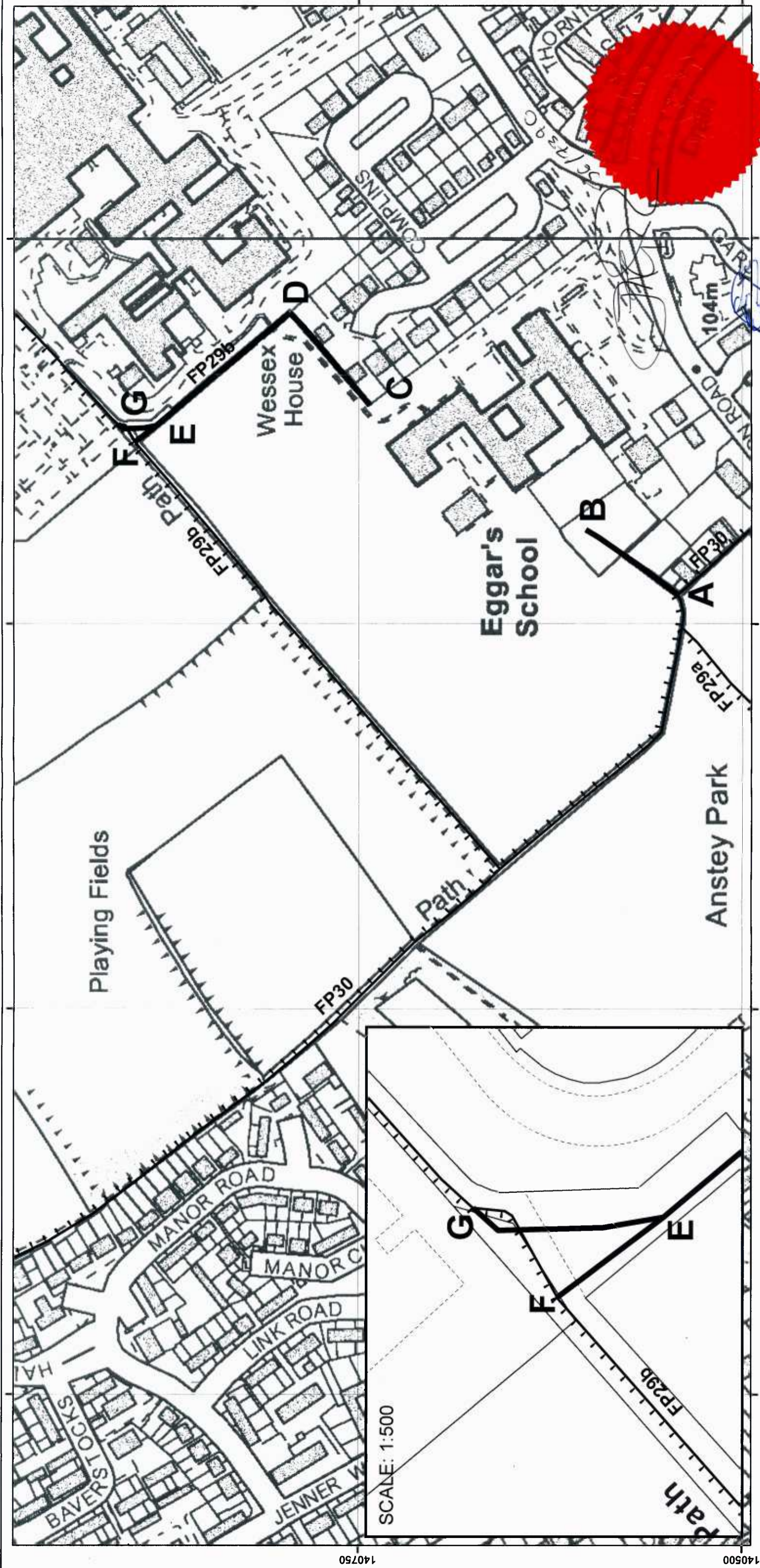
Alton Footpath 29b

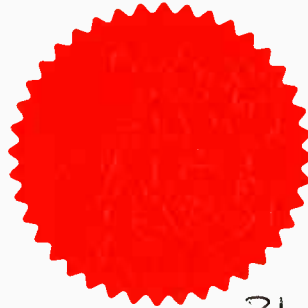
