1. The decision:

1.1. That an Order is made to divert part of Eversley Bridleway No. 11, under Section 257 Town and Country Planning Act 1990.

2. Reason(s) for the decision:

- 2.1. This diversion, which is sought by R Collard Limited, will enable the full implementation of planning permission at Eversley Quarry, granted by the County Council's Regulatory Committee on 18 December 2015. Currently the number of heavy plant movements in and out of the site is limited by the current positioning of the bridleway on the same line, and officers consider that it is necessary to divert the bridleway to allow the applicant to fully implement its planning permission. It is therefore recommended that an Order is made under s257 Town and Country Planning Act 1990.
- 2.2. The proposed diversion will offer a segregated, safer route for users who currently share it with Lorries and other large vehicles. It will have a minimum width of 5 meters between post and wire fences, and planting, with a 3 meter bridleway surface of compacted granular material, increased to 5 meters at crossings.

2. Impact on Crime and Disorder:


2.1. It is unlikely that this proposal will have any impact on reported crime in this area.
