Addendum to Agenda Item 6 of the Meeting of the River Hamble Harbour Management Committee on Friday 14 July 2017

- 3.104. 02 July. Patrol conducted routine pile checks. Moved a dory secured to a private pontoon. Routine liaison with Hamble Lifeboat. During the evening took a number of calls from River Users reporting two jet skis and a RIB travelling up river at high speed. Vessels located opposite Port Hamble Marina. Verbal warnings given for creating excessive wash. Patrol returned to Warsash. Further calls then taken reporting that these vessels had recommenced speeding. Patrol deployed in response, located vessels opposite Hamble Point Marina. Owners refused to give names or addresses. Patrol gave a HM Direction to all three vessels to leave the River and escorted them to the mouth under blue light.
- 3.105.03 July. Routine patrol and mooring checks. Nothing significant to report.
- 3.106. 04 July. Routine patrol and mooring checks. Liaison with Crown Estate contractors regarding routine pile maintenance work.
- 3.107. 05 July. Routine patrol and mooring checks. Assisted a yacht caught fast on the Warsash scrubbing ground. Responded to a call from Hamble Lifeboat about a group of 20 youths creating disorder on Hamble Jetty. Police informed.
- 3.108. 06 July. Routine patrol and mooring checks. Liaison with Gibraltar Police launch (new build) to facilitate compass swing. Recovered a sunken fibreglass dinghy from the River adjacent to Land's End. Recovered an abandoned canoe from 'H' pontoon to the Harbour Office.
- 3.109. 07 July. Routine patrol and mooring checks. Patrol responded to a call from Hamble Village regarding a large group of young swimmers at Hamble Jetty. Attended scene and cleared the water of swimmers who were informed both of the dangers (personal and to vessels) and of the Hamble Parish Council Bye Law prohibiting swimming there. Group dispersed on this occasion.
- 3.110. 08 July. Routine patrol and mooring check. Monitoring of bait digging in vicinity of a slip to ensure Bye Law 31a (6m proximity) not compromised. Routine liaison with Hamble Lifeboat. Clearance of more swimmers at Hamble Jetty.
- 3.111. 09 July. Routine patrol and mooring checks. Liaison with HMCG regarding the tow of a motor boat which had sustained damage because of a battery fire. Boat delivered to Stone Pier Yard for damage assessment. Assisted a RIB with engine failure to Warsash HM jetty. Liaison with Hampshire Constabulary regarding a small group of youths untying and causing damage to tenders at Hamble Jetty. Group left but returned each time Patrol left the scene.
- 3.112. 10 July. Routine patrol and mooring checks. Liaison with Hampshire Police Marine Unit regarding the theft of outboard motor theft from the Beaulieu River. Response to anti-social behaviour at the Hamble Jetty. On attending, managed to evict offenders from the Jetty and disperse them. Bait digging pattern of life monitoring a number of individual bait diggers. Patrol response to further ant-

- social behaviour by youths at Hamble Jetty with a number climbing on sailing club launches. Group dispersed successfully.
- 3.113. 11 July. Routine patrol and mooring checks. Liaison with boatyard regarding routine patrol boat maintenance programme. Routine liaison with Hampshire Marine Police Unit.
- 3.114. 12 July. Routine patrol and moorings check. Commercial tow of motor boat. Assisted owners of a yacht in picking up a mooring in strong tide. HM and DHM meeting with Hampshire Police local commander and Clerk of Hamble Parish Council at HPC to consider courses of action against anti-social behaviour at Hamble Jetty. Series of measures initiated including forward mapping of likely ASB activity and planned combined Police/RHHA activity, school briefings/engagement, signage review. A review of measures of effectiveness to take place post Summer.
- 3.115. 13 July. Routine patrol and moorings check. Hosted visits from two local schools to introduce the River and its benefits (as well as risks).
