1. The decision:

1.1 That an Order is made under Section 119 of the Highways Act 1980, to divert part of Breamore Footpath 17.

2. Reason(s) for the decision:

2.1 The applicant has applied for this diversion to improve privacy and security of their property, garden and outbuildings. It is a requirement that a diversion under Section 119 be either in the interests of the public or the landowner, and as the requested change is clearly in the landowner's interests, Hampshire County Council proposes to make the requested Order. A plan showing the route of the proposed diversion is attached.

3. Background

- 3.1 The definitive line of the path runs along a private access track, with the house to the south and the garages/outbuildings to the north. It then proceeds through the garden to a gate and into a field. In the past, items have been stolen from the outbuildings and walkers have been known to wander off the track, looking in the outbuildings and the house and garden.
- 3.2 The proposed route is not considered to be less convenient for the user, and it may take away the feeling of intrusion that some may experience when walking through the property. The proposed route is slightly shorter than the existing route, it is a 2.5-metre-wide grass path between stock proof fencing, with two pedestrian gates, one at Point E the other at Point D.
- 3.3 The proposed diversion route has been available as a permissive path for a while. The landowner had put in two very unstable stiles at either end of the route, and there was lots of overhanging vegetation and uneven ground. HCC asked the landowner to improve the route, to make it up to a standard which would be required to enable it to be certified. The landowner therefore changed the stiles to gates, levelled the ground where it was uneven and removed shrubs and overhanging tree branches. There is livestock in the field through which the

proposed diversion route runs, and so it was thought best to fence the route off to protect both the public and the livestock. A stock proof post and rail fence has now been installed either side of this section of the path, ensuring there was a minimum of 2.5 metres.

3.4 At the time the work was carried out to improve the path, concern was raised by the Ramblers of a possible disturbance of a badger sett. This was investigated by Natural England, the Police and the HCC Ecologist, and it was confirmed that no crime had been committed and that the actual badger sett was the other side of the hedging in the field. Although some local residents still maintain that the proposed diversion route will impact upon a badger sett, given the feedback from the above consultees, officers consider that this issue should not be a bar to the Order being made.
