1. Executive Summary

- 1.1. The purpose of this paper is to obtain delegated approval to make a range of minor adjustments to the Integrated Transport Programme.
- 1.2. Appendix 1 includes amendments across the ETE Capital Programme, resulting in a net increase in capital approvals totalling £410,000.
- 1.3. The schemes included are at different stages of development and delivery. Some may now be complete and will relate to older programmes, some are part of the current year, others will relate to the provisional forward programme.

2. Context

- 2.1. Capital financial regulations set out where delegated decisions can be made on a programme-wide basis.
- 2.2. The "last programme values" are the latest formally reported approval value. For older schemes this is most likely a project appraisal figure. For the current year, most will be project appraisal figures, for future years this is most likely the last EMETE capital update or Project Appraisal figure.
- 2.3. Appendix 1 does not include changes to the programme already approved as a result of a delegated PA, as this change is inherent in the approval.

3. Background

- 3.1. This report is aimed at improving transparency of the various minor amendments that are made to the published capital programmes.
- 3.2. It is intended that all delegated capital decisions for ETE (not Project Appraisals) can be made through this simple report, however it does not restrict separate decision reports being prepared where deemed necessary.
- 3.3. A summary of the decisions made should be included in an appendix to the quarterly Executive Member capital programme updates.

4. Finance

- 4.1. The six recommendations; three new entries, three amendments and one removal, as detailed in Appendix 1, result in a net increase in capital approvals totalling £410,000.
- 4.2. Where necessary, funding has already been identified to cover increases to the approvals. In cases of decreasing capital allocations, where it has been reallocated this has been identified
- 4.3. An adjustment to the maintenance and revenue implications of any cost increases has not been undertaken. For schemes that are yet to have a PA, the maintenance costs and revenue implications will be calculated then, as usual.

5. Recommendation

5.1. That the Director approves the recommendations set out in Appendix 1.

2020/21 County Highways Lab - Building and equipment improvements Requirement for change

New entry to the 2020/21 capital programme.

In February 2020, DMT agreed to vire £189,000 from the 2019/20 ETE revenue budget to fund capital investment in the Highways Laboratory.

This investment would cover an upgrade of Black Top laboratory equipment, to enable new bituminous testing methods (currently provided externally) that are more efficient, profitable and have a quicker turnaround time. It would also include an upgrade of the building to redress the underinvestment in the fabric of the building over the past decade and reduce rising maintenance costs.

2019/20 HWRC - Otterbourne Transfer Station - Equipment improvements

Requirement for change

New entry to the 2019/20 capital programme.

The waste contractor, Veolia, are undertaking capital works at the Otterbourne transfer station to install a full fire suppression system as a prevention method to remove the risk of fire damage. The full cost for works is £295,840.

Subject to approval, it is proposed that the waste disposal authorities (HCC, PCC and SCC) will contribute 50% of the costs (148,000) and the cost to HCC will be £114,000 which will be funded by unallocated HWRC refurbishment budget. This is on the basis that at the end of the waste disposal contract in 2030, the facility will revert to the disposal authorities and there will be 10 years useful life in the system that the authorities will benefit from. This improvement will increase the value of the site.

2020/21	EHDC – Whitehill Bordon GGGL Ennerdale Road – Phase 4 – Rear of Oakmoor School

Requirement for change

New entry to the 2020/21 capital programme.

This scheme is being proposed as part of the Green Grid Green Loop (GGGL) scheme in Whitehill and Bordon and will promote cycling and walking in the area by providing a 3m wide shared use path to the north of Oakmoor school. It is required to link together otherwise disconnected parts of the GGGL and follows on from the recently completed Ennerdale Road Phase 1 section of the GGGL Element 2, between Oakley Road and the rear of the school site.

Providing this link will contribute to the mitigation of two issues raised in the Whitehill and Bordon Sustainable Transport Improvements Package; poor transport infrastructure and connectivity resulting in a lack of alternative and sustainable transport options throughout the town; and severance and disconnection between old and new areas

These works are to be funded by Section 106 contributions.
