



NEW FOREST SHOW



Between Tuesday 25th July and Thursday 27th July the Commissioner and his team attended the New Forest Show. The team joined Hampshire Constabulary Country watch team in the countryside arena.



WE TOLD...

- Approx 90,000 attended
- Staff spoke to over 100 people over the 3 days of the show with 95 filling out surveys.



WE ACHIEVED...

Building on the rural conferences held earlier in the year were a wide range of issues that are of particular concern to rural communities, such as road safety, fly-tipping, Country Watch and Community Speedwatch schemes were discussed.







BIG ISSUES









ART AND YOUTH JUSTICE EVENT



In early July the Police and Crime Commissioner brought together a variety of organisations to put funding for services that support young victims, and those that help prevent young people from entering the criminal justice system, under the spotlight.

PARTNERSHIPS AND COMMISSIONING

COURT FILMS



Overview

Films being prepared of all crown and magistrates courts within HIOW which can be used by all CJS partners and commissioned services to familiarise victims and witnesses with court houses and the facilities when due to attend.

Outcome

Raise awareness of the court facilities and environment for victims and witnesses which will reduce the fear factor and increase confidence. Will be of particular use for those that have trials moved at short notice who then are not able to have a pre-trial visit.







BIG ISSUES









CYBER AMBASSADORS



Overview

- Members created a campaign (#GoFISH) to encourage young people to take precautions to protect themselves online, promote mechanisms to report concerns and highlight the laws around internet use
- Members recommended that cyber ambassadors should be introduced into schools
- The Youth Commission have trained 65 secondary students and 40 primary pupils as cyber ambassadors on their GoFISH resources

Outcome

Cyber Ambassadors pilot completed, progress towards a universal method of reporting, research issues young people are currently facing online

Overview

Developing a cyber profile of Hampshire, Isle of Wight,
Portsmouth and Southampton. To explore how we can keep
communities and those seen as more vulnerable to cyber crimes
SAFER. Cyber crimes comes in a number of formats and so needs
to be tackled in a number of ways to meet the needs of those
being targeted.

Outcome

To raise awareness of the different cyber crime targeting individuals and communities. Trying to keep on top of emerging cyber trends with the evolving use of technology to target victims. Support the Constabulary where possible on campaigns. To generate promotional materials. To co-deliver the cyber awareness conference in December 17.
