Purpose of this Report

1. The purpose of this report is to give the ETE select committee the opportunity to comment on the draft Local Transport Plan 4 before a decision is made to undertake public consultation.

Recommendation

2. That the Select Committee consider the draft LTP and make comments as they deem appropriate

Executive Summary

- 3. An LTP sets out the transport strategy for Hampshire and establishes the polices, strategies and high-level plans that guide how it will meet its statutory duties as a highway authority. It provides guidance to others, helps us choose and select our priorities and secure funding for measures to meet some of our most difficult movement challenges. As such it is a core part of the County Councils policy framework. Following a thorough process of engagement, data collection and impact assessment a draft LTP has been developed. A working copy (i.e. not the final publication version) is appended for consideration as Appendix 1. Also included is a working draft of the consultation survey form as Appendix 2.
- 4. A new LTP is needed because there have been significant changes in the policy and funding backdrop which means that the existing LTP is becoming increasingly out of date. It is also expected that the role of LTP's will shortly change and become directly related to future Government grant allocations for transport funding. Core LTP funding is currently allocated based on a formula, however the Government has signalled its intention to consider a return to the original LTP approach, when funding allocations were related to the quality of the LTP (in addressing national policy objectives) and its

- delivery. In the case of current national Transport policy, LTPs are potentially going to be judged against their effectiveness in supporting and catalysing decarbonisiation of the transport system, improving air quality and supporting modal shift to active travel and public transport.
- 5. The new LTP seeks to establish agreement to a vision of what transport should look like in 2050, four transport related outcomes covering climate change, environment, economy and society, and two core guiding principles for how we plan, design and delivery transport improvements in Hampshire. Collectively these highlight the problems and challenges we face and indicate the direction we propose to take to solve them.
- 6. The LTP includes core and theme policies which are set to achieve the outcomes, vision and core principles. These are the rules that apply to how Hampshire County Council proposes to manage and change the infrastructure and applies to what Hampshire does as a highway authority and what others might want to do to change the transport network. As rules, they are things Hampshire will not want to compromise on. Consultation will be an important test to see if the ones proposed will be viewed as making a difference to the desired outcomes.
- 7. The biggest difference to previous LTPs is:
 - a. creation of a user utility hierarchy
 - b. a movement and place framework to help us decide how best to change our streets and spaces and balance competing needs;
 - c. a new approach to integrating land use and transport planning by clearly defining what sustainable transport looks like;
 - d. an approach to adapting our infrastructure to respond to climate change;
 - e. policies that support decarbonisation and electrification of the vehicle fleet:
 - f. policies that set out how the County Council will make use of new technology to address transport challenges; and
 - g. policies that set the ambition to deliver a transformational change in public transport, walking and cycling networks and systems.

Next Steps

8. If approved for consultation the County Council will consult on the draft plan. This will involve a 12 week consultation being undertaken. Following consultation, the feedback received will be analysed and used to review the draft document. The intention is then to take a revised LTP for approval through the relevant governance structures, which for a document forming part of the statutory policy framework, would require recommendation from Cabinet for approval by Full Council. If adopted the plan would replace the

- existing LTP and become part of the new policy framework for the County Council.
- 9. Select Committee may wish to consider what role it would like to play to support the post consultation approval process.
