### **Consultation around guidance 2018**

- Guidance covers what support should parents receive, schools putting pressure on parents to EHE, safeguarding, pupil voice, flexi schooling.
- All arrangements to be proportionate, sensible and allow LA's to focus on families who are most at risk or need most support to provide a suitable education
- Asked about adequacy of information flow, sanctions (both parents and schools), trial periods, SAO's, monitoring, access to exams



#### **Private Members Bill**

- Changes to the law.... Passed committee stage. However withdrawn 15 March 2019
- Key changes were around registration, monitoring and support
- This together with change to guidance could have significant impact on LA allocation of resource.

- 1421 Hampshire children are EHE do Governors ask who has come off roll and why?
- Why are so many parents voting with their feet and are unhappy with state education?
- Many parents and pupils have had a negative experience of education – especially if their child has SEN – what can we do to improve matters?
