Addendum to Agenda Item 7 of the Meeting of the River Hamble Harbour Board on Friday 30 July 2021

- 12.124. 19 Jul. Commercial tow of a yacht to a boatyard for lift-out. Pumped out inundated tenders at Warsash. Liaison with Hampshire Marine Police Unit. Attended channel North of M27 bridge to liaise with boatyard regarding antisocial behaviour from adjacent farmland. Responded to a call from a member of the public reporting anti-social behaviour at Bursledon A27 Bridge. Responded to a call from a Hamble public House landlord reporting antisocial behaviour at Hamble Jetty and outside the establishment. Advised to call 101/999.
- 12.125. 20 Jul. Recovered an unattended anchored RIB from Swanwick to HM Pontoon Warsash. Liaison with Marine Police Unit to register the RIB as not being stolen in case of report. Liaison with a Hamble tender berth holder reporting criminal damage to tenders. An anchor from the Pink Ferry had been stolen and used to break the locks on each tender. No tenders stolen. Reported to the Police. Recovered a small abandoned tender from the Badnam Creek marsh. Stopped and warned verbally to speeding jet skis in the mouth of the River compliant. Received a call from a member of the public reporting anti-social behaviour opposite Eastlands Boatyard. Police called.
- 12.126. 21 Jul. Hailed by a berth holder at Eastlands Boatyard to report anti-social behaviour the previous evening. A group had trespassed on the pontoon from adjacent farmland and had climbed on and dived from moored private vessels. When challenged, they had become verbally threatening and refused to depart. Patrol advised the person reporting to report the matter to the Police at the time but he could not get through on 101. Patrol then advised him to either dial 999 if anxious or to use the online reporting tool. Attended Hamble Jetty on two occasions to disperse three groups of swimmers compliant. Liaison with Hampshire Marine Police Unit in regard to general nuisance created by those engaged in ASB at various locations.
- 12.127. 22 Jul. Liaison with the Pink Ferry regarding criminal damage at Hamble Jetty. The Ferry mooring lines and tender mooring lines had been untied. Police had been informed. Pumped out an inundated tender on a mid-stream mooring. Recovered four chairs from the upper River. Returned to Hamble Jetty to disperse a group of swimmers compliant. Attended the mouth of the River to disperse a group of swimmers in the Main Channel. Towed a yacht with engine failure from the mouth of the River back to her proper mooring for defect rectification. On passing Eastlands Boatyard, witnessed a group of around 10 youths climbing on and jumping from the bridge of a private motor vessel. On noticing patrol, they dispersed to the fields opposite. Witnesses in adjacent berths were advised to report the matter to the Police if there was a reoccurrence. Attendance at Hamble Quay to disperse swimmers compliant. Recovery of lost property from Warsash Slipway.
- 12.128. 23 Jul. Gave assistance to the owner of a RIB in launching at Warsash.

 Recovered a small tender adrift in the Main Channel off HM Pontoon

 Warsash. Owner traced and tender returned. Support to Harbour Wall works.

Liaison with Hamble Life Boat. Recovered a young person stranded on a mid-stream pontoon. Recovered to Hamble Quay. Responded to a call from the on-duty Pink Ferry skipper reporting ASB at Hamble Jetty. Police called. Liaison with Hamble Life Boat. Pumped out an inundated tender on a mid-stream mooring. Removed three swimmers from the Main Channel off Swanwick. Recovered a large log from the Main Channel off RHCP Jetty. Assistance given to a small tender with engine failure in the Main Channel at Swanwick. Liaison with the Crown Estate Mooring Contractor.

- 12.129. 24 Jul. Pumped out an inundated tender on a mid-stream mooring. Owner informed. Liaison with Police regarding a vessel of interest. Assistance given to two paddleboarders overcome by ebbing tide at Swanwick. Stopped a motor vessel with 11 persons on board, one of whom jumped deliberately overboard off Warsash. Vessel stopped. Skipper warned but some of the passengers were evidently intoxicated. Skipper apologetic. Vessel escorted to her marina berth.
- 12.130. 25 Jul. Received a report from a member of the public reporting a fallen tree in the Upper River. Recorded for assessment on next high tide.
- 12.131. 26 Jul. Patrol boat maintenance. Moved a visiting yacht from a private mooring to the mid-stream Visitors' Pontoon. Dispersed a group of swimmers from hamble Jetty compliant.
- 12.132. 27 Jul. Liaison with Hampshire Marine Police Unit. Liaison with a boatyard regarding an incidence of theft. Recovered an apparently abandoned tender to HM pontoon. Moved on an individual fishing, who had secured to a private mid-stream moored yacht. Moved on a visiting vessel which had anchored in the approaches to Hamble Jetty. Advised of Bye Laws. Removed a group of swimmers from pontoons at Eastlands Boatyard compliant. Responded to a call from a member of the public reporting a small RIB towing a paddleboard at speed in the Upper River. Vessel located and warned compliant.
