

Addendum to Agenda Item 6 of the Meeting of the River Hamble Harbour Board on Friday 6 October 2019

- 8.67 12 Sep. Inspection of fallen tree at Botley. Recovered an abandoned kayak to Warsash. Light audit.
- 8.68 13 Sep. Signage work at RHCP jetty and Warsash slipway. Towed a resident motor vessel with propulsion failure to her berth.
- 8.69 14 Sep. Recovered two logs from the Main Channel in the Upper River. Advice given to a training yacht regarding Byelaw 16 (prohibited anchorage).
- 8.70 15 Sep. Monitoring of algal bloom in Upper River. Replacement of signage at RHCP Jetty. Advice given to the driver of a RIB for excessive speed and wash off Crableck.
- 8.71 16 Sep. Liaison with the owner of a mid-stream moored vessel regarding non-compliant pile lines. Support to RSPB volunteers conducting a bird count. Support given to a kayak pair struggling against flood tide. Assistance given to the owner of a mid-stream moored yacht reporting a collision.
- 8.72 17 Sep. Support to a marine casualty (head injury) occurring outside the river.
- 8.73 18 Sep. Support to Southern Inshore Fisheries Conservation Authority in hosting routine meeting. Moorings survey on behalf of the Moorings Officer. Attended Hamble Jetty to disperse 3 youths climbing on and diving from the moored Pink Ferry – compliant.
- 8.74 19 Sep. Advice given to a mooring holder regarding temporary berthing. Secured a loose boom on a mid-stream moored yacht. Observed collision damage to a second mid-stream moored yacht. Liaison with owners.
- 8.75 20 Sep. Recovered a large deck cushion from the Main Channel to Warsash. Light traffic in stronger winds and rain. Moorings inspection on behalf of the Moorings Officer.
- 8.76 21 Sep. Tide Gauge cleaning at Crableck and Swanwick. Liaison with HMCG and Hamble Lifeboat to track down location of a transmitting safety beacon. Checked for removal of fallen tree near the Bark Store (Botley) – complete.
- 8.77 22 Sep. Towed a yacht with propulsion failure from Crableck to her marina berth for defect rectification. Adjusted lines on a mid-stream moored yacht. Followed up a report from a River User of a speeding motor vessel in the mouth of the River. CCTV check for the reported timeframe. No evidence found.
- 8.78 23 Sep. Recovery of a drifting inflatable tender from the Main Channel to Warsash. Stopped and warned rider of a jetski for excessive speed and wash off Crableck.
- 8.79 24 Sep. Light traffic – enhanced moorings inspection following strong winds.
- 8.80 25 Sep. Liaison with a member of the public reporting camper vans parked at the higher end of Swanwick Slipway.

- 8.81 26 Sep. Response to a report of a diesel fuel spillage off Hamble. On investigation, a small amount of diesel had entered the water following an overflow of tanks. Fuel afloat contained by local absorbent booms. Residue dispersed by jet wash from Patrol Craft. Routine liaison with Hampshire Marine Police Unit. Liaison with Calshot Lifeboat.
- 8.82 27 Sep. Support given to a paddleboarder blown upstream and unable to return to launching point. Liaison with Hampshire Marine Police Unit regarding a vessel of interest.
- 8.83 28 Sep. Stopped and warned a large resident motor vessel for excessive wash off Warsash.
- 8.84. 29 Sep. Visit of HCC CEO, Carolyn Williamson, and Assistant Director Jo Heath.
- 8.85 30 Sep. Assistance given to a mooring yacht in berthing. Light traffic.
- 8.86 01 Oct. Support to grounded small yacht off Lands End.
- 8.87 02 Oct. Towed a large branch from the Main Channel off Swanwick to Warsash for recovery and disposal. Liaison with Hampshire Marine Police Unit regarding a vessel of interest.
