Addendum to Agenda Item 7 of the Meeting of the River Hamble Harbour Board on Friday 12 January 2024

- 7.42 13 Nov. Liaison with the Crown Estate mooring contractor regarding pile iron repair work. Liaison with affected mooring holders.
- 7.43 14 Nov. Monitoring support to the Solent Oyster restoration project.
- 7.44 15 Nov. Pile survey in support of the Crown Estate mooring contractor. Preparations for annual commercial billing round.
- 7.45 16 Nov. Tow of a section of a tree to Warsash for disposal. Light traffic.
- 7.46 17 Nov. Routine survey of River Hamble Country Park Jetty. Re-positioning of a mid-stream moored yacht. Recovery of a pallet from the Main Channel. Identified a failed pontoon mooring chain on a mid-stream mooring. Liaison with owner.
- 7.47 18 Nov. Recovered a small empty oil drum from Land's End and returned to Warsash for disposal. Pumped out flooded cockpit in a small mid-stream moored yacht. Righted and pumped out a capsized tender at Hamble Jetty. Pumped out inundated tenders at Warsash.
- 7.48 19 Nov. Stopped and warned a speeding tender at Swanwick – compliant.
- 7.49 20 Nov. Recovered a large blue plastic empty barrel from the bank adjacent to the Chinese Bridge.
- 7.50 21 Nov. Monitoring support to the Solent Oyster restoration project. Tide gauge cleaning off Crableck.
- 7.51 22 Nov. Liaison with a mid-stream mooring holder to arrange fitting of new lines. Tow of a small motor vessel to a marina.
- 7.52 23 Nov. Liaison with the owner of a yacht reporting an 'altercation' with the skipper of an outbound motor vessel (unnamed) at the mouth of the River. CCTV footage inconclusive. Commercial tow of a small yacht from HM Jetty Warsash to her proper mooring.
- 7.53 24 Nov. Commercial making-up of mooring lines. Routine support to UK Border Force. Liaison with and support to a visiting sailing school.
- 7.54 25 Nov. Commercial fitting of pile lines to a mid-stream moored yacht. Routine audit of aids to navigation.
- 7.55 26 Nov. Light traffic. Targeted moorings checks on behalf of the Moorings Officer.
- 7.56 27 Nov. Responded to a call from a River User reporting an outbound speeding motor vessel off Crableck. Vessel intercepted off Warsash within speed limits.
- 7.57 28 Nov. Liaison with Hampshire Marine Police Unit. Liaison with a Marina following a report of theft.

- 7.58 29 Nov. Fit-out and test of replacement salvage pump – correct. Transport support to Hampshire Police Officers. Light traffic.
- 7.59 30 Nov. Light traffic. Patrol to Botley and Curbridge.
- 7.60 01 Dec. Preparations for dredging operations at a River Marina. Tow of a motor vessel from HM Jetty Warsash to her proper mooring.
- 7.61 02 Dec. Light traffic. Continued preparation for dredging operations. Liaison with affected mooring holders and tows to Visitors' Pontoon.
- 7.62 03 Dec. Light traffic.
- 7.63 04 Dec. Liaison with HM Coast Guard to trace a radio safety notification within the River – Hamble Life Boat in attendance. Liaison with Hampshire Marine Police Unit to trace a vessel of interest.
- 7.64 05 Dec. Response to a call from a Marina reporting an abandoned tender. Tender identified. Liaison with Police and owner to return.
- 7.65 06 Dec. Liaison with the Crown Estate mooring contractor to repair failed pile iron bolts. Liaison with the affected vessel owner to move to Visitors' Pontoon pending defect rectification.
- 7.66 07 Dec. Light traffic. Fit-out and positioning of RHHA Christmas afloat display.
- 7.67 08 Dec. Monthly First Aid equipment checks. Targeted pile line checks.
- 7.68 09 Dec. Liaison with the Environment Agency to report an apparent discharge of material near Botley, reported by a member of the public 1045hrs. Patrol attended 1115. EA incident number raised for investigation. Video evidence provided.
- 7.69 10 Dec. Patrol to Curbridge – tree inspection. Check of apparent discharge after incident at 7.68 – no further evidence.
- 7.70 11 Dec. Tow of vessel from her proper mooring to Visitors' Pontoon pending completion of pile iron repair work. Liaison with the Crown Estate Mooring Contractor.
- 7.71 12 Dec. Return of vessel displaced at 7.70 following completion of works. Towed an abandoned tender from Land's End to Warsash. Liaison with a property owner at Land's End regarding a break-in to a boat house.
- 7.72 13 Dec. Tow of a yacht from the Visitors' Pontoon to her proper mooring following contractor repair works.
- 7.73 14 Dec. Liaison with Hampshire Police regarding reported thefts. Attended a mid-stream moored yacht apparently low in the water. Some water within. Pumped out – liaison with owner. Light traffic.
- 7.74 15 Dec. Jet wash of Fishermens' Jetty and Link Span.. Routine exercise planning with Hampshire Marine Police Unit.

- 7.75 16 Dec. Light traffic.
- 7.76 17 Dec. Assistance given to a small launch broken down off Crableck. Towed to her Club for defect rectification. Hailed by the owner of a moored yacht reporting that his tender had fallen adrift and floated upriver. Tender recovered and returned.
- 7.77 18 Dec. Liaison with a Marina regarding failing sheet pile walling.
- 7.78 19 Dec. Liaison with Hamble Lifeboat. Inspection of walling at 7.77. Warsash HM Bridge repair works completed.
- 7.79 20 Dec. Observed a parted mooring line on a mid-stream moored yacht. Made safe and liaison with owner.
- 7.80 21 Dec. Commercial tow of a yacht to her marina berth. Liaison with Hampshire Police.
- 7.81 22 Dec. Pump-out of inundated tenders at Warsash. Light traffic.
- 7.82 23 Dec. Assistance given to Bird Aware Solent (bird count). Targeted moorings check on behalf of the Moorings officer.
- 7.83 24 Dec. Light traffic.
- 7.84 25 Dec. Office closed. Emergency contact as usual via HM Coast Guard.
- 7.85 26 Dec. Light traffic. High speed test of Patrol Craft in Southampton Water.
- 7.86 27 Dec. Very light traffic.
- 7.87 28 Dec. Enhanced moorings inspection following strong winds. Replaced displaced fenders on several mid-stream moored yachts. Liaison with the owner of a mid-stream moored yacht with parted pile lines.
- 7.88 29 Dec. Patrol to Botley and Curbridge to inspect channel for fallen trees – none witnessed.
- 7.89 30 Dec. Enhanced moorings inspection following strong winds. Replaced displaced fenders on several mid-stream moored yachts. Check and pump out of a small inundated yacht and replacement of cover. Liaison with owner.
- 7.90 31 Dec. Repositioned fenders on several mid-stream moored yachts following strong winds. Liaison with visiting Calshot Lifeboat.
- 7.91 01 Jan. Commercial tow of a yacht to her proper mooring.
- 7.92 02 Jan. Resecured loose sail cover on a midstream moored yacht. Resecured a sailing club yacht with a broken mooring cleat. Liaison with club. Re-positioning of fenders following strong winds.
- 7.93 03 Jan. Light traffic – patrol craft maintenance.
- 7.94 04 Jan. Tow of a small yacht to her proper mooring following completion of dredging operations.

- 7.95 05 Jan. Pumped out inundated tenders at Hamble Jetty. Recovered an abandoned tender from the bank near the Chinese Bridge and returned to her owner.
- 7.96 06 Jan. Commercial line replacement for a mid-stream mooring holder.
- 7.97 07 Jan. Re-secured a loose mooring line on a midstream moored yacht. Attended three yachts reported as being low in the water. Some water in cockpits of each, cause by blocked drains. Cleared.
- 7.98 08 Jan. Pile inspection in advance of routine Crown Estate pile replacement programme. Mooring check on behalf of license holder.
- 7.99 09 Jan. Light traffic. First Aid equipment checks.
