Addendum to Agenda Item 6 of the Meeting of the River Hamble Harbour Board on Friday 12 April 2024

- 7.45 27 Feb. Pump out of inundated craft at Warsash. Targeted moorings check on behalf of Moorings Officer.
- 7.46 28 Feb. Marina liaison. Routine patrol craft maintenance. Light traffic.
- 7.47 29 Feb. Recovered a large log rom the Main Channel in the Upper River.
- 7.48 01 Mar. Check of a mid-stream moored yacht on behalf of her owner. Pumped out cockpit. Liaison with owner. Commercial tow of a yacht. Resecured a loose halyard and block on a mid-stream moored yacht. Recovered No 11 light from the Shore adjacent to the Pink Ferry hut. Light showed signs of collision. CCTV investigation proved that light had been working throughout the night until around 0400 in foul weather when an inbound vessel (unidentifiable) had struck the mark off Warsash College Jetty. Light base repaired and light refitted.
- 7.49 02 Mar. Preparations for Trinity House Light Audit (4 March). Pumped out inundated yacht at owner's request.
- 7.50 03 Mar. Recovered a large branch from the Main Channel off Bursledon.
- 7.51 04 Mar. Pump-out of inundated tenders at Warsash. Survey of RHCP Jetty. Liaison with Hampshire Marine Police Unit regarding persons of interest. Annual Trinity House Light Inspection.
- 7.52 05 Mar. Liaison with Hampshire Marine Police Unit. Light traffic in heavy rain.
- 7.53 06 Mar. Attended RHCP Jetty following a report of a missing deck board. Replaced.
- 7.54 07 Mar. Liaison visit from HCC Wildlife Crime Police Officer. Liaison with Hampshire Marine Police Unit regarding persons of interest. Commercial fitting of new pile lines.
