Addendum to Agenda Item 6 of the Meeting of the River Hamble Harbour Management Committee on Friday 8 September 2017

- 3.22. 07 Aug. Patrol conducted routine pile checks. Patrol moved yachts to accommodate a barge at the midstream Visitors' Pontoon.
- 3.23. 08 Aug. Routine patrol and mooring checks. Returned a recovered tender to her owner at Lands End. Conducted routine liaison with Hamble Lifeboat. Patrol responded to a call reporting a man in the water in the Secondary Channel. On attendance, man had fallen from his yacht while mooring. Man recovered and, after first aid treatment for cold, taken to his car at Hamble Jetty. Checks of the 'M' moorings prior to routine Crown Estate maintenance work.
- 3.24. 09 Aug. Routine patrol and mooring checks. Following a call from a member of the public, attended Hamble Jetty where a moored vessel was apparently taking on water. Vessel pumped out prior to move to a yard for defect rectification.
- 3.25. 10 Aug. Routine patrol and mooring checks. Measurement of available pontoon space in advance of the Bursledon Regatta.
- 3.26. 11 Aug. Routine patrol and mooring checks. Patrol applied advice notices to two craft having moored without payment of Harbour Dues. Bait digging observation.
- 3.27. 12 Aug. Routine patrol and mooring checks. Patrol applied advice notices to two further craft having moored without payment of Harbour Dues. Patrol gave assistance in berthing to a motor boat with propulsion difficulties. Patrol pumped out a motor boat taking on water at Warsash. Defect rectified.
- 3.28. 13 Aug. Routine patrol and mooring checks. Routine liaison with Hampshire Marine Police Unit. Preparations for the Bursledon Regatta. Patrol responded to call from a yacht reporting a 'hit and run' collision. Conducted an investigation with adjacent berth holders. No witnesses. Recorded for insurance purposes as well as consideration at the next Operational and Safety Meeting.
- 3.29. 14 Aug. Routine patrol and mooring checks. Patrol assisted in the recovery of a vessel at Warsash slipway. Patrol warned a small RIB for creating excessive wash near the midstream Visitors' Pontoon.
- 3.30. 15 Aug. Routine patrol and mooring checks. Routine liaison with the Crown Estate maintenance contractor regarding pontoon replacement. Routine Marina liaison. Liaison with the Bursledon Regatta Committee and boat owners prior to movement to clear the fall-out zone for the Regatta fireworks.
- 3.31. 16 Aug. Routine patrol and mooring checks. Routine liaison with the Crown Estate Mooring Contractor regarding planned maintenance work. Assisted a motor boat with manoeuvring difficulties to her proper berth. Following a complaint regarding swimmers and anti-social behaviour, attended Hamble

- Jetty. Swimmers dispersed prior to arrival. Patrol dispersed two swimmers from the Fishermen's Jetty at Warsash. Support to Wednesday evening dinghy racing.
- 3.32. 17 Aug. Routine patrol and moorings checks. Investigated the source of a smell of diesel at Mercury bend. Source of leak not found. Sheen broken up with propellor wash. Moved four yachts from moorings on the 'M' run prior to planned Crown Estate maintenance work.
 - 3.33. 18 Aug. Routine patrol and moorings checks. Commercial tow of a catamaran from the A27 Bridge to the HM Pontoon. Towage of a condemned pontoon to a boatyard for disposal. Routine liaison with the Crown Estate contractor regarding forthcoming maintenance programme. Pile replacement survey with the Crown Estate contractor.
 - 3.34. 19 Aug. Routine patrol and moorings checks. Re-secured loose mooring lins on 'J' run. Mooring holder informed. Assisted a yacht aground on Hook spit.
 - 3.35. 20 Aug. Routine patrol and moorings checks. Liaison visit with the Pink Ferry regarding concerns at anti-social behaviour at Hamble Jetty. Routine Sailing Club liaison. Assisted a yacht with engine failure alongside the Harbour Master's jetty.
 - 3.36. 21 Aug. Routine patrol and moorings check. Affixed non-payment sticker to a yacht alongside at Hamble Jetty. Warned the owner of a catamaran for diesel pollution following bilge pumping. Diesel broken up with propellor wash. Continued preparations for the Bursledon Regatta (construction of HM 'U' Boat).
 - 3.37. 22 Aug. Routine patrol and moorings checks. Towed two yachts back to their proper moorings following completion of routine maintenance work on the 'M' run. Patrol responded to a yacht with a foul mooring. Yacht freed and owner informed. HM responded to a Coast Guard call reporting a casualty on board a yacht inbound from sea. Liaison with HMCG, Police, Ambulance and CG helicopter. Casualty evacuated to Southampton hospital with a suspected heart attack.
 - 3.38. 23 Aug. Routine patrol and moorings checks. Commercial tow of a yacht to a local boatyard for maintenance. Return of a yacht to her proper mooring following completion of routine maintenance. Re-attached free mooring line on a mid-stream moored yacht. While on patrol off Hamble Jetty, patrol made aware of a 5 year old boy who had been recovered from the water by the skipper of a passing yacht. The boy had fallen into the water from an upstream pontoon while unsupervised. Ambulance and Police on scene and boy recovered. The boy has since recovered and this is the subject of a separate investigation with the organisation in question. He had been involved in shore-based activity.
 - 3.39. 24 Aug. Routine patrol and moorings checks. Liaison with the Crown Estate contractor regarding the forthcoming pile maintenance programme.

- 3.40. 25 Aug. Routine patrol and moorings checks. Return of two yachts to their proper moorings following completion of planned Crown Estate maintenance on the 'M' run. Routine liaison with the Crown Estate contractor regarding planned maintenance work.
- 3.41. 26 Aug. Routine patrol and moorings checks. Further preparations for the Bursledon Regatta. Support to the Regatta. Movement of last yachts to clear the fall-out zone for the Fireworks. Nothing significant to report with a very well organised and attended event.
- 3.42. 27 Aug. Routine patrol and moorings checks. Changed failed stern mooring line on a mid-stream moored yacht. Owner informed. Return of vessels to their proper moorings following the Bursledon Regatta fireworks. Responded to a call from a boatyard reporting anti-social behaviour by a group of youths above the A27 bridge. On arrival, the youths had dispersed.
- 3.43. 28 Aug. Routine patrol and moorings checks. Noted petrol and diesel had run out at fuelling stations in the River following the Bank Holiday weekend and insufficient deliveries. Shared via social media. Patrol craft refuelled from organic stores held for that purpose.
- 3.44. 29 Aug. Routine patrol and moorings checks. Patrol affixed a non-payment sticker to a visiting motor-boat. Bait digging observation between Salterns and the Bursledon bend. Assisted a PhD student in hydroponic research project. Patrol responded to further report of anti-social behaviour at Hamble Jetty along with the Police. Swimmers dispersed. Responded to further report of swimmers above the M27 bridge. On arrival, these had also dispersed.
- 3.45. 30 Aug. Routine patrol and moorings checks. Took report of theft of a petrol tank. Towed a motor-boat back to her proper mooring from the midstream Visitors' Pontoon following completion of planned maintenance work on the 'M' run. Responded to a call from a River user regarding a floating branch within the channel off the 'H' run. On arrival, nothing found.
- 3.46. 31 Aug. Routine patrol and moorings checks. Further assistance given to a Southampton University PhD student project. Further bait digging observation at Warsash. Observed a deposition of material in a yard above MHWS and above the A27 bridge. Subject of ongoing investigation. Towed a yacht from Hamble Jetty to a mooring adjacent to the Pink Ferry Hard. On evening patrol, stopped and warned a jet-ski North of Mercury Marina for speeding.
- 3.47. 01 Sep. Routine patrol and moorings checks. Routine liaison with Crown Estate mooring contractor regarding the forthcoming pile maintenance programme. Routine liaison with a number of marinas. Responded to a call from a River user of a speeding motor-boat off Mercury bend. Photographic evidence provided for subsequent warning of skipper.
- 3.48. 02 Sep. Routine patrol and moorings checks. Monitoring of bait digging adjacent to the Harbour Office. Bait digger compliant.

- 3.49. 03 Sep. Routine patrol and moorings checks. Support to Hamble Lifeboat in recovery of the crew of a RIB, broken down outside the River. Boat towed to her home yard.
- 3.50. 04 Sep. Routine patrol and moorings checks. Routine liaison with Hampshire Constabulary. Towed a yacht with propulsion defect from the mouth of the River to a yard for defect rectification.
- 3.51. 05 Sep. Routine patrol and moorings checks.
