- 1.1 The County Council to enter into partnership arrangements under Section 75 NHS Act 2006 with the Hampshire and Isle of Wight Integrated Care Board (HIOW ICB) and NHS Frimley Integrated Care Board for hospital discharge services as set out in this report.
- 1.2 That the Executive Lead Member for Adult Social Care and Public Health give delegated authority to the Director of Adults' Health and Care in consultation with the Executive Lead Member for Adult Social Care and Public Health to agree the terms and conditions of any Section 75 Agreement for hospital discharge services and to approve associated spend.

2.1 This report seeks approval to enter into arrangements with the Local Integrated Care Board(s) under S75 NHS Act 2006 in compliance with the County Council Constitution
