1.1. That the Executive Member for Culture, Recreation and Countryside approves the proposal to make Traffic Regulation Orders under section 1 of the Road Traffic Regulation Act 1984 to restrict all motorised users with 3 wheels or more on Bentworth Byway Open to All Traffic Nos. 23, 27 & 28 and Wield Byway Open to All Traffic Nos. 19 & 20 and to amend the draft Order to restrict all motorised users with 3 wheels or more on Wield Byway Open to All Traffic No 17, Selborne Byway Open to All Traffic No 67 and Worldham Byway Open to All Traffic No 38.

2. Reason for the decision:

- 2.1. Hampshire County Council is responsible for the protection and maintenance of over 4500 km of Public Footpaths, Bridleways, Byways open to All Traffic and Restricted Byways. These routes provide access for recreation and amenity and are important to enable people to explore and enjoy Hampshire's countryside.
- 2.2. This is a more sustainable management model for the maintenance of byways that will reduce the need for major capital expenditure. By adopting a more dynamic approach to the application of TRO's it is anticipated that damage to the byways will be reduced, particularly during extreme weather, and the routes continue to be accessible.
