- 1.1 That approval is given by the Executive Member for Adult Social Care and Health to award a grant of up to £374,257, for up to 6 months from 1 April 2019, to Basingstoke and Deane Borough Council to allow the continuation of existing Social Inclusion services in the area during the Transformation to 2019 review period.
- 1.2 That approval is given by the Executive Member for Adult Social Care and Health to give delegated authority to the Director of Adults' Health and Care to agree the extension term and the associated grant amount to be awarded to Basingstoke and Deane Borough Council as detailed in 1.1 above.

2. Reasons for the decision:

2.1 This decision is being sought to allow sufficient time to implement any proposed changes to services that may be agreed by the Executive Member for Adult Social Care and Health in the second half of the 2018/2019 financial year following completion of the review process that is currently being undertaken.

3. Other options considered and rejected:

3.1. Not to offer the grant extension recommended within this report. This option was rejected as it would result in Basingstoke and Deane Borough Council being unable to extend existing Social Inclusion contracts. This may result in a gap in service provision within the area and cause disruption for vulnerable service users.

1. The decision:

- 1.1. That the Executive Member for Adult Social Care and Health gives approval to spend up to the maximum value of £3m over ten years on a 5+3+2 basis to commence from April 2019 for the proposed catering contract for Willow Court Nursing Home.
- 1.2. That the Executive Member for Adult Social Care and Health agrees to a survey being completed by residents within six months of implementation to provide feedback on the new arrangements and ascertain if any further improvements are required.

2. Reasons for the decision:

- 2.1 In 2005 when the Willow Court Nursing Home was constructed as part of the Enhance Programme it was decided that the provision of catering would be provided under contract with the adjacent Andover Memorial Hospital. At the time the cost of this arrangement was deemed reasonable. In the event of the hospital site closing an Option Agreement provides for land to be made available to build a kitchen for the care home.
- 2.2 The current contract with Hampshire Hospital NHS Foundation Trust is due to expire on the 31 March 2019.
- 2.3 Currently the arrangement for the service is provided by Hampshire Hospitals Foundation Trust and the meals prepared and delivered from Andover War Memorial Hospital. The contract value for 2018/19 is £224,000.

3. Other options considered and rejected:

3.1. Do nothing – the contract expires on the 31 March 2019, and the department needs to ensure a continuation of a catering service for Willow Court Nursing Home.

- 3.2. Take over the Kitchen at Andover War Memorial Hospital Hampshire Hospital NHS Foundation Trust has confirmed it does not wish to consider this option.
- 3.3. Build a bespoke kitchen as part of Willow Court Nursing Home as outlined in the report this is not a financially or logistically feasible.

1. The decision:

That the Executive Member for Adult Social Care and Health gives approval:

- 1.1. To spend up to £31,380,000 in order to procure a new Technology Enabled Care service for an initial five years, to commence on 10 December 2018.
- 1.2. To spend up to a further £36,030,000 in order to extend the Technology Enabled Care service contract by a further period of up to five years should that be deemed appropriate and required, bringing the total contract length to 10 years, at a cost of up to £67,410,000.
- 1.3. To extend the existing Technology Enabled Care contractual arrangements from 31 July 2018 for a period of up to six months, at a value of up to £1,160,000. This will provide a continuity of service during the procurement period, and allow for an implementation and handover phase, should this be required.

2. Reasons for the decision:

2.1 The permission to spend will enable a procurement exercise to be held which will seek a partner that is capable of delivering core Technology Enabled Care requirements as a managed service, whilst delivering the innovation, commercial capability and significant and meaningful strategic input that will be required in future years.

3 Other options considered and rejected:

3.1 To allow contracts for Technology Enabled Care services to come to an end without making provision to replace these services from 31 July 2018 onwards. This option was rejected as the Council recognises the need for Technology Enabled Care services, given its role in reducing costs in social care by investing in innovative technology, whilst also improving quality of life and maintaining service user independence in their own homes for longer.
