59. APOLOGIES FOR ABSENCE

None received.

60. DECLARATIONS OF INTEREST

Members were mindful that where they believed they had a Disclosable Pecuniary Interest in any matter considered at the meeting they must declare that interest at the time of the relevant debate and, having regard to the circumstances described in Part 3, Paragraph 1.5 of the County Council's Members' Code of Conduct, leave the meeting while the matter was discussed, save for exercising any right to speak in accordance with Paragraph 1.6 of the Code. Furthermore Members were mindful that where they believed they had a Non-Pecuniary interest in a matter being considered at the meeting they considered whether such interest should be declared, and having regard to Part 5, Paragraph 2 of the Code, considered whether it was appropriate to leave the meeting whilst the matter was discussed, save for exercising any right to speak in accordance with the Code.

61. MINUTES OF PREVIOUS MEETING

The minutes were agreed and signed.

62. DEPUTATIONS

63. CHAIRMAN'S ANNOUNCEMENTS

The Chairman congratulated the Children's Services department on the recent 'Outstanding' OFSTED rating. The Chairman welcomed Cllr Carpenter on joining the Board and wished to record the Board's thanks to Cllr Chadd for her time as Chairman and wish her all the best in her new role as Executive Member for Education.

64. CHILDREN IN CARE PARTICIPATION UPDATE

The Corporate Parenting Board received a report from the Director of Children's services in relation to an update on participation of Children in Care. The key aim was to recruit a new cohort of Care Ambassadors and the Board heard that the County had been divided into four areas for this purpose. The Participation Officer is committed to representation from Unaccompanied Asylum Seeking Children, Disabled Children and Children in Care from Residential Homes. The Panel noted that the Participation Strategy had been in place since 2017 and is now embedded across Districts.

In response to questions, members heard that;

- Stability for Children in relation to Social Worker churn continued to be a top priority.
- Changing language was important to ensure a focus on children and young people's expectations.

Resolved: That the Corporate Parenting Board note the update on the current focus of working practices for Officers working with Children in Care.

65. UPDATES ON CHILDREN IN CARE - HEALTH ASSESSMENTS

The Corporate Parenting Board received a report from the Director of Children's services in relation to Health Assessments for Children in Care. The Board heard how the health of Children in Care has been an area under significant focus in order to improve the timeliness of assessments.

The Board received an overview of Initial & Review Health Assessments alongside immunisation and dental information.

Following a serious case review, all assessments enable the young person to speak to the health professional without their carer present to ensure that the voice of the child is heard.

Resolved: That the Corporate Parenting Board note the report and the update on the current focus of working practices for Officers working with Children in Care.

66. CHILDREN IN CARE EDUCATION UPDATE

The Corporate Parenting Board received a report from the Director of Children's services in relation to the Education of Children in Care.

The Board received an overview of the Personal Education Plans which are a statutory active document for looked after children. This document sets out identified needs, school history, targets and the child's views about their education.

In response to questions, members heard that;

- The Designated Teacher, Foster Carer and Social Worker all act in the role of the parent in relation to education.
- There are efforts to have a member of the County SEN team with an oversight for Children in Care.

- The Designated Teacher passes on their knowledge to other teachers within the school.

Resolved: That the Corporate Parenting Board note the update provided in relation to Education for Children in Care.

67. **JOINT HOUSING PROTOCOL**

The Corporate Parenting Board received a report from the Director of Children's services in relation to the reviewed joint working protocol between Hampshire's Children's Services Department and District Housing departments. This was as a result of the expanded duties for local authorities in the Homelessness Act 2017 in relation to housing for 16 & 17 year olds.

Resolved: That the Corporate Parenting Board note the contents of the report and agree that the key challenges will be considered by the Corporate Parenting Board.

1. Recommendation(s)

- 1.1 That the Corporate Parenting Board note the update on the current focus of working practices for Officers working with Children in Care.

2. Summary

- 2.1 This report focuses on the period since 01 June 2019 and provides a brief overview of the Participation Officer's progression of work over the last three months.

3. Future Direction

- 3.1. Children's Social Care will continue to work to improve outcomes for Children in Care.
- 3.2 This report provides an update on the progress of Participation for Children in Care across Hampshire Children's Services. The progress is being measured against the Participation Strategy. The Participation agenda is embedded within practice across the teams and districts and a culture of creating an inclusive "You Said, We Did" continues.

4. Participation Leads

- 4.1 The Participation Officer continues to support the Children in Care Teams across the county with the participation agenda. The Participation Officer has chaired two district participation meetings in each of the four quadrants. Each quadrant consists of two districts.

Fareham and Gosport Havant	South East Quadrant
East Hampshire Hart and Rushmoor	North East Quadrant

New Forest Eastleigh Winchester	South West Quadrant

- 4.2 The participation meetings have included participation team leads from Children in Care Teams, Residential Services, the Fostering Service and the Independent Reviewing Service, Care Leavers Teams and these meetings have included the district teams. The meetings have provided a platform to share ideas for participation and continues to build on a collaborative strength-based approach central to the ethos of the Hampshire Approach.
- 4.3 Eleven District and Service participation leads met for an away day on 05 September 2019 to share best practice and to plan for the participation conference that will take place on 31 October 2019. The leads were introduced to the Evolve risk assessment tool which will support with the safe implementation for the increasingly adventurous participation activities that the teams are setting up for their children and young people.

5. Care Ambassadors

- 5.1 The Participation Officer continues to support the recruitment of Care Ambassadors at both a local, service and county level. The local groups are beginning to establish, and the North East quadrant have five young people who meet regularly, of which two attended the County Group meeting on 02 September 2019 with the Corporate Parenting Board and the Director and Assistant Director of Childrens Services. The Participation Officer will directly support the County Group and support the quadrant participation leads with the promotion and support of the Care Ambassadors a local level. The Participation Officer is supporting the Service groups which are in the early stages of recruitment.
- 5.2 The Participation Officer coordinated and took part in the first Corporate Parenting Board 'Influencers group' on 06 September 2019. This is a group of Children in Care who are under 18 years old and therefore unable to be

representatives in Corporate Parenting Board meetings. The Participation Officer will support this group to meet with the Corporate Parenting Board outside of the Corporate Parenting Board meetings and will promote their views. They will also provide their views and feedback to the Care Ambassadors. The Participation Officer hopes that these children will eventually become Care Ambassadors once they reach 18 years of age and two of these young people have formally expressed an interest in becoming a member of the Corporate Parenting Board.

- 5.3 The Participation Officer has met with Children and Young People in care across the districts and found some common themes in that:
- Children in care would like to be involved with interviews for staff.
 - Children in care would like to share their own story to social work staff.
 - Children in care would like to access a therapeutic group.
- 5.4 A group of Unaccompanied Asylum-Seeking Children (UASC) continue to meet in London. This group is facilitated by a Personal Assistant from the South East Care Leavers Team supported by a Social Worker from the South East Children in Care Team and a Social Worker from the Havant Children in Care Team. A representative from this group of young people attended the County Group meeting on 02 September 2019 with the Corporate Parenting Board and the Director and Assistant Director of Children's Services. This young person has expressed an interest in becoming a Care Ambassador representative on the Corporate Parenting Board. Another Unaccompanied Asylum-Seeking Children group has been set up by the Basingstoke Children in Care Team and this group also meets in London.
- 5.5 The Participation Officer has been liaising with the Service Lead for Disabled Children's Teams to explore a Care Ambassador group and representation from disabled children. It has been agreed that the Participation Officer will support the formation of a group or groups in schools that disabled children attend as this may be a more facilitating environment for these groups to flourish.
- 5.6 The Participation Officer is in the early stages of supporting the formation of a Care Ambassador group from children's residential homes. The Participation Officer has met with residential home managers to discuss the representation of children and young people from the residential homes.
- 5.7 The Participation Officer is exploring the possibility of forming a Care Ambassador group from children in care living in Out of County placements. The group would be facilitated using social media such as SKYPE. The

Participation Officer is currently seeking guidance about the use of SKYPE with these children before taking this forward.

6. Introduction to care leaflets and video

- 6.1 The 'Introduction to care' for under 14's leaflet is in the final stages of completion following feedback from young people. The leaflet has now been signed off and is awaiting just one last amendment with the designers. The design team will now focus on the leaflet for over 14's. Once the leaflets are complete they will be made available to Social Workers who can use them as an additional resource to inform and support children who may be coming into care.
- 6.2 The 'Introduction to care', an animated video, is due to start production. This will be a further resource alongside the Introduction to care leaflet that Social Workers can use to reassure and support children coming into care. The leaflet will provide information and the animated video will offer reassurance. The Hampshire Cultural Trust have supported the Participation Officer to identify a video company to produce the video. The Video Company have agreed to produce the video animation for less than half the usual cost. The video script was sent out to participation leads for consultation to children in care and staff.
- 6.3 The Unaccompanied Asylum-Seeking Children (UASC) group have already completed a 'Welcome to Hampshire' leaflet which has been approved by senior managers. This leaflet has been signed off and is being finished by the design team. The leaflet will be published first in English and then it will be available in five languages identified as the most commonly spoken languages for UASC in Hampshire. This will be a valuable resource for Social Workers working with separated young people who have recently arrived in Hampshire and are seeking asylum.
- 6.4 Fostering Services have involved children and young people in care in delivering training to potential foster carers. Children and young people are also part of fostering panels.
- 6.5 The Independent Reviewing Service have appointed Andrew Beard in the role of the Participation Lead Officer for the Service. In response to children and young people's views, the Independent Reviewing Service have adapted how they record meetings and now record as if talking directly to the child.

7. Participation Events

- 7.1 Seven districts have recorded eleven events from 01 June 2019 to date with 167 children and young people and 135 parents and carers taking part. Fareham and Gosport and Hart and Rushmoor have organised large scale events that have included Children in Care.
- 7.2 Residential Services recently arranged several participation activities for their children. Several young people engaged in a variety of activities including kayaking, camping, visits to Thorpe Park and one group of three children visited Disneyland for a week-long holiday. Each of these opportunities were arranged in response to the wishes and feelings of the children. Each home records how the children have shaped the service in a folder that they keep in each home.
- 7.3 The Participation Officer recently attended Fareham and Gosport and Havant Olympic participation day. Each team arranged an activity and arranged for children to be present including Children in Care. There was a huge number of participants and a variety of fun and exciting activities and the day had a real buzz of excitement about it with children and staff clearly enjoying themselves.

- 7.4 The Participation Officer attended the Big Adventure Week run by the Hampshire Futures Team for children in care, which ran all week from 05 to 09 August. Four Hampshire Outdoor Centres were involved enabling four week-long residential arrangements with twenty children staying in each centre. The children and Children's Services staff had the opportunity to try a variety of activities and this provided an opportunity to get to know one another.
- 7.5 These events have provided the Participation Officer with a rich source of in-depth interviews and insight into the day to day experiences of children in care as well as their views about the service they receive. The Participation Officer has provided a sample of the numerous quotes from the children and young people gathered during these events:

10 year old child in care to the Participation Officer.... "Thank you so much for talking to us. This has been the best part of the whole week for me."

20 year old young mum: "More things like this. More little events. I think a lot of people in care get a lot of mental health issues and little events like this do help. Now I am living on my own and whenever my PA mentioned it I thought, do you know what, it gets me out. I just mentioned to her it would be nice having more older people not just with the little ones. Yes, more people should know about this and there should be more events like this."

60 year old Nan / carer: "I cannot fault my grandson's social worker. Her and the Children in Care team in Fareham and Gosport. But, his social worker is second to none. They are just brilliant. When 'X' was kicking off, and he is a big lad, two of them came and supported me. One took the child and the other took me. There was no need to do that. It was above and beyond."

60 year old Foster carer: "I have noticed a change in the last year. Especially from my support workers. They are more on it and attentive."

7.6 The main themes over that past three months regarding 'you said' and 'we did' are listed below.

You said	We did
"The children feel they are listened to but sometimes the number of meetings are frustrating."	
"We liked that the manager joined in the participation event as we normally only see her at meetings. We liked how much effort has been put into the day as there is a lot going on."	
"I really enjoyed the activities, especially the slime and graffiti art." "A child was scared of dogs prior to the event, we had a PAT (therapy dog) on site, who calmed the nerves of the child and made him feel more comfortable around animals." "Feel more confident." "I like talking to my [FSW name]." 	

<p>One family said they have not been out of the house for 6 weeks, this is the first thing they have come to. This has built up their confidence to get out of the house and become independent again.</p>	
<p>“My social worker listens to us and our mum and will talk to all of us.”</p> <p>“My social worker listens to me and helps me to sort the problem.”</p> <p>The children said social workers: ”They help the children that are scared. They help to get worries out of their heads.”</p> <p>“They make sure you are fed properly and make sure you are happy.”</p> <p>“They help you from being hurt. pictures of animals with funny faces and you can tell them how you are feeling.”	
“It was good fun and I am glad I came.” “Was a long train journey from London but I had a nice time.”	
Young people and carers said they appreciated the ‘free event’ at the end of the summer when money was short, and families needed a bit of support.	
Events in school term do not work well as families struggle to juggle competing needs of family life. Future events should be in school holidays.	We will arrange events in the school holidays.
More events like this. If the family attends, then the allocated Social Worker should attend also. More food requested as the children enjoyed this.	We will plan the next event to include the feedback and to amend the feedback forms to get more useful feedback.

8. Next Steps

8.1 The language that we use

The language that we use is a key theme from participation events. The Participation Officer acknowledges that we need to consider changes to our language within review documents, care plans, visit records and our verbal dialogue with children and their families. Such information crosses many aspects of the department, for example within our guidance, policies and procedures. The language we use is currently being developed and the Participation Officer is coordinating feedback from children and young people and from staff regarding what language our children and young people would like us to use.

9. Conclusion

9.1 The last three months has been a busy and productive time for the Participation Officer. The Participation Officer has found that feedback from our Children in Care evidences that generally there are positive relationships between children and their parents/carers and Children’s Services staff. There is a strong sense of children and their families being well supported by

staff and the department. Working relationships between staff and children and their families are generally viewed as authentic, open and positive. The teams have organised some creative and exciting events which have provided some rich feedback from children and their families.

- 9.2 The Participation Officer is particularly excited about the progress of the Care Ambassadors as a group and the enthusiasm from the Participation leads in facilitating involvement of Care Ambassadors as participants in the Corporate Parenting Board or as 'influencers.
- 9.3 Going forward the Participation Officer will continue to support the Participation leads for the Children in care Teams. The Participation Officer will also continue to support staff with resources such as the Introduction to care leaflet and video and the Welcome to Hampshire leaflet. The Participation day has been organised for 31 October 2019 and this will be another opportunity to ensure that participation remains high on the agenda and remains creative, fun and focused.

She came home smiling, full of enthusiasm, telling us tales of all her new adventures and friendships.

It really has helped his confidence and social skills.

I have never seen her so excited over something and emotional.

I can't actually put into words as to how much she enjoyed it and the friendships that she made.



Feedback from foster carers

They were talking non-stop of all the exciting activities they participated in.

She hasn't stopped talking about all she did and how much she wants to return if she's able to.

This has helped hugely with her confidence, to share experiences with other children who feel like she does and an opportunity to know people that understand how her life is a bit more complex.

The kids were all in the same boat and it seemed to normalise and make things easier for her. She finds it difficult making friends, as 'regular' kids don't get her and she feels isolated. It was so not the case this week.

He suffers from anxiety and speaking with him when I collected him, I was amazed that he had tried all the activities and was so proud of his achievements.

The boys felt less different when they came home as they'd had the chance to meet other children who were similar to them. It was lovely for them to see that they're not alone.
