1. The Decision:

1.1 That the Executive Member for Education and Skills grants spend approval to the project proposals for Osborne School, Winchester at the total cost of £1,583,000.

2. Reasons for the decision:

- 2.1 Osborne School is a maintained special school for pupils with learning disabilities aged 11 to 19 with a capacity for 197 pupils. These proposals will increase the capacity by 20 places to 217 pupils through the provision of a separate satellite facility for Osborne School pupils located on the nearby Kings' School site in Winchester.
- 2.2 The project proposals provide a stand-alone facility in a new building with provision for 3 classrooms for Osborne School pupils on the Kings' School site.
- 2.3 The project was included in the Children Services Capital Programme, approved at the Executive Lead Member for Children's Services and Young People Decision Day on 10 January 2020, with a budget of £1,200,000. Additional funding is required over and above the original allocation as abnormal technical constraints including a previously undetected water main were identified during the later design stage. Additional funding of £383,000 is therefore required in order to overcome the technical constraints of the site.
