 - It is recommended that additional grant of £0.724m (including fees) is added to the 2017/18 programme in order to progress the design of the new Boorley Park Primary School.
 - Owing to the difficult site conditions at Kings Furlong Infant and Junior Schools, it is recommended that additional funding of £0.9m (including fees) is added to this scheme from the 2017/18 programme.
 - Owing to the difficult ground conditions and structural and site issues at Oakwood Infant and Greenfield Junior schools, it is recommended that additional funding of £0.8m (including fees) is added to this scheme from within the 2017/18 capital programme.
 - It is recommended that £0.511m be transferred from the 2017/18 capital programme contingency to the Children's Services revenue budget.
 - It is recommended that the additional grant for a project at Swanwick Lodge Childrens Home of £0.165m is added to the 2017/18 programme.

- d) That it is recommended that approval be given for the application of planning permission for modular buildings to be located on the sites listed at Appendix 3.
- e) That It is recommended that authority be delegated to the Director of Children's Services to revise and if necessary add to sites for the modular buildings listed in Appendix 3 following receipt of updated information on pupil numbers early in the spring term.
