#### **Purpose of this Report**

- 1. The purpose of this report is to provide feedback on eleven statutory public notice periods in relation to the proposed expansions of:
  - Saxon Wood School
  - Forest Park School
  - St. Francis School
  - Riverside School
  - Hollywater School
  - Bedenham Primary School
  - Glenwood School
  - Lakeside School
  - South View Infant and Junior Schools
  - Ashley Infants School
  - Wildground Infant and Junior Schools
- 2. To obtain final approval for these projects to proceed.

#### Recommendations

That approval be given to the following proposals: published by Hampshire County Council under Section 19 (1) of the Education and Inspections Act 2006:

3. To make a prescribed alteration to Saxon Wood School, Rooksdown, Barron Place, Basingstoke, Hants, RG24 9NH (category of school: Special) to expand from 34 places to 44 places, with effect from 1 September 2021.

- 4. To make a prescribed alteration to Forest Park School, (Primary site): Ringwood Road, Totton, Hampshire, SO40 8DZ and (Secondary Site): Commercial Road, Totton. Hampshire, SO40 3AF (category of school: Special) to expand from 124 places to 140 places with effect from 1 September 2021.
- 5. To make a prescribed alteration to St. Francis Special School, Patchway Drive, Oldbury Way, Fareham, Hampshire, PO14 3BN (category of school: Special) to expand from 94 places to 104 places with effect from 1 September 2021.
- 6. To make a prescribed alteration to Riverside Community Special School, Scratchface Lane, Purbrook, Hants, PO7 5QD (category of school: Special) to expand from 125 places to 137 places with effect from 1 September 2021.
- 7. To make a prescribed alteration to Hollywater School, Mill Chase Rd Bordon, Hampshire, GU35 0HA (category of school: Special) to expand from 128 places to 136 places with effect from 1 September 2021.
- 8. To make a prescribed alteration to Glenwood School, Washington Road, Emsworth, PO10 7NN (category of school: Special) to expand from 97 places to 103 places with effect from 1 September 2021.
- To make a prescribed alteration to Bedenham School, Bridgemary Avenue, Gosport, Hants, PO13 0XT (category of school: Community) to expand their Resourced Provision from 8 places to 12 places with effect from 1 September 2021.
- 10. To make a prescribed alteration to Lakeside School, Winchester Road, Chandler's Ford, Eastleigh, SO53 2DW (category of school: Special) to expand the capacity of the school from 92 places to 97 places with effect from 1 September 2021.
- 11. To make a prescribed alteration to South View Infant and Junior Schools, Shooters Way, Basingstoke, Hampshire, RG21 5LL (category of school: Community) to develop 2 new Resourced Provisions, creating 9 infant places and 12 Junior places with effect from 1 September 2021.
- 12. To make a prescribed alteration to Wildground Infant School, Armitage Avenue, Dibden Purlieu, Southampton, Hampshire, SO45 4LG (category of school: Community) to expand their Resourced Provision from 8 places to 16 places to include places for pupils with Autistic Spectrum Disorder with effect from 1 September 2021.
- 13. To make a prescribed alteration to Ashley Infant School, Lower Ashley Road, Ashley, New Milton, Hampshire, BH25 5AA (category of school: Community) to expand their Resourced Provision from 16 places to 24 places with effect from 1 September 2021.

#### **Executive Summary**

- 14. This report seeks to provide feedback on eleven statutory public notice periods in relation to the proposed expansions mentioned above and to obtain final approval for these projects to proceed.
- 15. Hampshire County Council has a statutory duty to provide school places for all children including those who have special educational needs and/or a disability. The County Council is committed to further developing successful provision to meet this demand within the Special Education Needs and Disability (SEND) sector.
- 16. These proposals aim to build on good quality Hampshire school provision; meet the needs of pupils with Special Educational Needs; reduce the Local Authority's dependence on INMSS and keep pupils as close to their home and community as much as possible.
- 17. All eleven projects have been to public consultation with specific agreement from the Executive Member for Education and Skills (at that time). The notices were published from 4 June to 2 July 2021.

### Saxon Wood School

- Saxon Wood School is a Special School, designated for primary age children with Physical Disabilities and Complex Medical Needs, with an Agreed Pupil Number of 34.
- 19. The proposal is to demolish a single classroom, which is in poor condition, and replace with a new double-classroom unit allowing an additional ten pupils to attend the school. External landscaping, play areas and car park works are included. Reconfiguration of the main school entrance and some internal refurbishment works will also be undertaken.
- 20. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. No objections were received.
- 21. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### Forest Park School

22. Forest Park School is a 124-place special school catering for 2–19-year-old pupils with moderate, severe, and profound learning difficulties and is across 2 sites, with an Agreed Pupil Number (APN) of 124.

- 23. The proposal is to install a double modular building on the Primary Site, Ringwood Road which will allow the school to increase the capacity by up to an additional 16 places from September 2021. The works will provide additional accommodation for children in the Early Years so that space is released in the main building to enable more primary and secondary aged children to attend the school.
- 24. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. No objections were received.
- 25. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

### St Francis School

- 26. St Frances School is a special school for pupils and students aged between 3 and 19 who have a wide range of severe, complex, and profound and multiple learning difficulties, with an agreed APN of 94.
- 27. The proposal is to retain a single classroom unit that has been utilised during current major refurbishment works. This will allow the school to increase their Agreed Pupil Number by 10 to 104. Additional landscaping and car park works are included in this project.
- 28. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. A local Councillor, who is also a Governor of the school requested a full report for the increased APN and associated works. No objections were received.
- 29. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### **Riverside Community Special School**

- 30. Riverside is a primary school for pupils aged between 4-11 with learning difficulties, with an agreed APN of 125.
- 31. The proposal is to add an additional double classroom that will allow the school to increase the capacity on the main site by 12 places and provide greater flexibility of the learning environment for all pupils.
- 32. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. No objections were received.

33. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### Hollywater School

- 34. Hollywater School caters for pupils aged between 2–19-years with moderate, severe, and complex learning difficulties, with an APN of 128.
- 35. The proposal is to undertake some internal works and small extension which will allow the school to increase the capacity by up to 8 places, from September 2021. The works will provide appropriate internal teaching accommodation and toilets to create an overall capacity of 136 places to enable more children to attend the school and improve the overall learning environment.
- 36. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals. A request was made for a copy of the consultation document and a copy of the complete proposal and the answers to some follow up queries regarding the organisation of the classed were responded to. No objections were received.
- 37. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### Glenwood School

- 38. Glenwood School caters for pupils aged between 11 and 16 years with learning difficulties (MLD) and has an APN of 97.
- 39. The proposal is to add an additional classroom unit which will allow the school to increase the capacity on the main site and create an additional 6 specialist ASD (Autistic Spectrum Disorder) places from September 2021.
- 40. The works will provide additional teaching accommodation to enable more children to attend the school and allow greater flexibility of the learning environment for pupils with more complex needs. This will give a final overall capacity of 103 places.
- 41. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and a comment in support was received from the local Councillor. No objections were received.
- 42. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

### **Bedenham Primary School**

- 43. Bedenham Primary School has an 8-place Resourced Provision for children with Social, Emotional and Mental Health needs and is meeting the needs of these children in a supportive, safe, and secure environment and has an excellent wellbeing and mental health aware environment for all children attending.
- 44. The proposal is to refurbish an under-utilised area of the school and outdoor space to create a new area in the school for the Resourced Provision and increase the capacity by an additional 4 places.
- 45. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. No objections were received.
- 46. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

### South View Junior and Infant School

- 47. South View Junior and Infant School has an existing successful Resourced Provision for 16 children with Speech, Language and Communication Needs at the Junior School site, and 18 children at the nursery and infant site.
- 48. The proposal is to add 2 standalone and separate Resource Provision (RP) classes for children with Moderate Learning Difficulties (MLD) and other additional needs.
- 49. These will be split as follows: The Infant School RP will be for 9 children; and the Junior school will be for 12 children, with potential to increase in future years if need arises.
- 50. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. No objections were received.
- 51. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### Lakeside School

- 52. Lakeside School is a 92-place school, for children with Social, Emotional, Mental Health, aged 11 to 16 years.
- 53. The proposal is to increase the Agreed Pupil Number from 92 to 97 and to lower the age range, enabling children aged 10 years old to attend, suing existing teaching spaces.

- 54. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and no comments regarding the proposal. No objections were received.
- 55. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### Wildground Infant & Junior Schools

- 56. Wildground Junior and Infant Schools have 2 established Resourced Provisions on their sites.
- 57. The Early Learning Group, which is a joint Education and NHS provision for pre-school children with speech, language, and communication needs. The other is a provision for 8 pupils, ages between 5 and 11 years and caters for Social, Emotional and Mental Health Needs.
- 58. The proposal is to expand the current SEMH Resourced Provision to better meet the needs of the current cohort, and potentially create 8 additional places filled over 3 years for children with autism. This would require a small investment of approximately £12,000 for refurbishment and resources.
- 59. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and a comment of support was received from a parent of a child that attends the school. No objections were received.
- 60. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

#### **Ashley Infant School**

- 61. Ashley Infant School has an established and successful 16 place Resourced Provision that caters for children aged between 2 years 9 months up to the end of Year Two (Age 7), with severe learning difficulties. The unit is a specialised base for children with diagnosed medical and/or severe and complex learning difficulties and an adult to child ratio is at the most 1:4.
- 62. The proposal is to utilise current classroom accommodation to create 8 additional places, which means that the APN would be increased to 24 for the Academic Year 2021/22 onwards.
- 63. A public notice, outlining the refurbishment and expansion, was published on 4 June 2021. The department received no requests for complete proposals and a comment in support was received from the Head Teacher of Arnewood School, who expressed 'insufficient inclusion capacity within the locality across all ages, including notably key stage 1. This expansion will address this concern. We note the associated capital cost seem to represent good value for money and the outcome seems achievable within a reasonable

- timescale. no comments regarding the proposal. No objections were received'.
- 64. A copy of the Public Notice is appended (Appendix 1). The County Council complied with all statutory requirements relating to the publication of the Public Notice.

### **Consultation and Equalities**

- 65. An Equality Impact Assessment (EIA) has been completed.
- 66. Formal consultations took place between 4 June and 2 July 2021. The proposal was also included on the County Council's consultation website. Letters were sent to parents of children at the schools, residents, headteachers, Chairs of Governors (CoG), school staff, Headteachers, CoGs at all schools within 2 miles, and special schools in the districts, Local Councillors, local Dioceses, Union Representatives, Local MP's, HCC Elected Members.
- 67. The proposals are positive for the protected category of 'Disability' and will provide more facilities for 3–19-year-old pupils with a range of Special Educational Needs; allow more pupils to attend the schools in their local communities and be with an appropriate peer group.
- 68. The impact on the other protected characteristics was neutral.

#### **Climate Change**

- 69. Hampshire County Council utilises two decision-making tools to assess the carbon emissions and resilience impacts of its projects and decisions. These tools provide a clear, robust, and transparent way of assessing how projects, policies and initiatives contribute towards the County Council's climate change targets of being carbon neutral and resilient to the impacts of a 2°C temperature rise by 2050. This process ensures that climate change considerations are built into everything the Authority does.
- 70. The carbon mitigation tool and the climate change adaption tool were not applicable because this is a strategic capital programme report. The Climate Change Impact Assessment will be undertaken in conjunction with colleagues in Culture, Community and Business Services as individual projects are developed and brought to future Decision Days.

#### **Conclusions**

71. In considering the supportive responses received, the County Council believes that the developments of the Schools and Resourced Provisions, as detailed above, are necessary to meet the County Council's statutory duty for children with SEND, and that the comments received did not represent

sufficient concern to prevent final approval for these developments, so that they can be ready in time for the new Academic Year in 2021.

# ASHLEY INFANT SCHOOL, NEW MILTON – EXPANSION OF RESOURCED PROVISION

- Notice is hereby given, in accordance with Section 19(1) of the Education and Inspections Act 2006, that Hampshire County Council intends to make a prescribed alteration to ASHLEY INFANT SCHOOL, Lower Ashley Road, Ashley, New Milton, BH25 5AA (category of school – Community) by increasing the capacity of the resourced provision of the school, with effect from 1 September 2021.
- 2. The current capacity of Ashley Infant School is 180. The resourced provision currently has capacity for 16 pupils with severe learning difficulties (SLD). It is proposed to create capacity at the resourced provision by offering 8 new places, bringing the capacity of the resourced provision to 24. This will not affect the overall capacity of mainstream places at Ashley Infant School.
- The capital cost of this project, £25,000, will be included in the Children's Services Capital Programme report to the Executive Lead Member for Children's Services in July 2021. This funding provides for the development of interior spaces and associated furniture and equipment.

This funding provides for the purchase and installation of a new double modular classroom, landscaping and other works to accommodate increased pupil numbers.

# GLENWOOD SCHOOL, EMSWORTH – INCREASE OF AGREED PUPIL NUMBER

This funding provides for the purchase and installation of a new single modular classroom, landscaping and other internal works to accommodate increased pupil numbers.
