#### 1. The decision:

- 1.1 That the Executive Lead Member for Children's Services approves the award of additional HAF Summer grants to the organisations identified in Appendix 1 of the full report up to a total value of £37,645.
- 1.2 That the Executive Lead Member delegates approval to the Director of Children's Services to approve the allocation of remaining HAF contingency funds up to a maximum of £298,525 to organisations delivering services that meet the criteria of the grant set out in paragraph 19, in consultation with the Executive Lead Member. This may include new grants to partner organisations to supplement the HAF Summer offer where gaps are identified at a local level, and individual grant awards may exceed £5,000.
- 1.3 That the Executive Lead Member delegates approval to the Director of Children's Services to approve the allocation of HAF grant funds to partner organisations supporting the signposting HAF aim, up to a maximum of £50,000 to organisations delivering services that meet the criteria of the grant set out in paragraphs 19 and 23, in consultation with the Executive Lead Member. This may include new grants to partner organisations to supplement the HAF Summer offer where gaps are identified at a local level, and individual grant awards may exceed £5,000.

#### 2. Reason for the decision:

2.1 To meet the Department for Education's Holiday Activity and Food grant programme objectives in Hampshire.

### 3. Other options considered and rejected:

3.1 Hampshire County Council could have chosen not to commission Summer holiday activity and food schemes via the Department for Education's HAF

grant programme. However, it was agreed that such services would be beneficial to vulnerable children across Hampshire.
