Can you please confirm what steps are being taken to protect our environmentally important chalk streams, in particular confirming what is being done to prevent four wheel drive vehicles crossing the River Meon in Droxford, via the U189, causing substantial damage in the vicinity?

2. From Councillor Kim Taylor to Councillor Rob Humby, Leader and Executive Member for Policy, Resources and Economic Development

In full council on 29<sup>th</sup> September the Leader reassured Members that he was engaging with Hampshire's MP's, the Government, the Department for Levelling Up, Housing and Communities and Treasury officials to ensure the County Council's forecast position is fully understood and what the consequences will be if they are not addressed in time. Can the leader please provide an update on activities undertaken and any progress made?

3. Councillor Alex Crawford to Councillor Jan Warwick, Executive Member for Climate Change and Sustainability

The Secretary General of the United Nations highlighted the increased urgency of action needed on climate change, when he opened COP27 this month by stating that the clock is ticking with the planet fast approaching tipping points that make climate chaos irreversible.

He called for greater urgency, stronger action, and effective accountability.

Will Council therefore revisit its Climate Change Strategy and Action Plan to aim to be carbon neutral earlier than the present target of 2050 and to prepare to be resilient to the impacts of temperature rises greater than the present level of 2°C?

I welcome the news of a New School at Hounsome Fields in my division. Given the significant amount of Development, I would like to understand how the pressure on primary school places will be managed?
