





The Police & Crime Plan Dashboard is used to monitor the status of delivery derived from monthly highlight reports, and provides oversight of change within the projects with access to a closer level of detail via hyperlink to each individual project.

- · Reporting months can be selected to identify the status of delivery at each period
- All 122 project objectives are tracked using a RAG rating for "Evidenced", "Current", and "Outstanding"
- The delivery of the plan is measured as a percentage of all objectives that are "Evidenced"

Ensure Violence Reduction Units continue across Hampshire and the Isle of Wight.


Encourage the use of effective 'stop and search' to make communities safer for young people.

Evidenced: Deliverables have been successfully achieved and the relevant objectives have been successful.

Current: Project objectives are being actively tracked and delivery is in progress, however cannot yet be fully demonstrated.

Outstanding: Project deliverables have yet to be fully scoped and / or product delivery has not been started.

Project has been 100% evidenced since March 2023

Considerable progress has been made in using data and analysis to identify issues, training for frontline staff and more intelligent scrutiny. Measures now include:

- Revised approach on analysis to better inform stop & search use
- Greater connectivity with intel to encourage greater emphasis on intel led searches
- Supervisor Body Worn Video (BWV) review dip sampling with an emphasis on learning
- CPD training on Stop & Search delivered to local policing
- Revised training package devised for student cohorts delivered
- · Peer learning panel
- Creation of Stop Search Champions on teams
- Revised district narratives to inform communities regarding the use of stop and search


The stop and search scrutiny panel engages members of the public in viewing BWV and feeding back on findings. HIOW have invested in training aimed at increasing confidence in using powers.

Serious Violence Reduction Partnership Board has been established to ensure core governance is in place to tackle serious violence and oversees sub-groups including:

- Tactical Violence Reduction Partnership Working Group
- Data and Analysis Working Group
- **Engagement Working Group**
- **Communications Working Group**
- Interventions, Opportunities & Evaluations Working Group

The Violence Reduction Partnership encourages a Public Health Approach, with members engaging widely with young people at partners to explain the benefits of being trauma informed.

Work is underway to develop a common data platform, Hampshire and Isle of Wight Together to work in collaboration between HIOWC and TVP.

Trauma Informed Executive (TIE) Board

The VRU commissioned WAVE Trust to support the OPCC in working alongside 18 organisations who have signed the Trauma Informed Concordat by developing a Trauma Informed Strategy and bespoke delivery plans. This is designed to embed Trauma Informed practice across public services and the Trauma Informed Executive (TIE) Board Oversee the delivery of the Concordat. This Board is made of partners from the following organisations:

- Office of the Police & Crime Commissioner
- Hampshire and Isle of Wight
 Adult Services (HIPS) Constabulary
- Hampshire and Isle of Wight
 Winchester Prison Fire & Rescue Service
- HIOW Integrated Care Board
 Southern Health

- Public Health (HIPS)
- Children's Services (HIPS)
- Probation
- Solent NHS

Trauma Informed is also a priority of the Integrated Care Partnership (ICP) for which the PCC is the Senior Responsible Executive (SRE).

Trauma Informed Strategy

The Trauma Informed Strategy was reviewed by the TIE Board in October 2023, and it was agreed to take forward four recommendations in the first instance:

- Increase the number of staff who understand the 6 national principles of Trauma Informed practice e.g. through training, leadership programmes, reflective practice, CPD etc. The 6 national principles are:
 - Safety

Collaboration

o Trust

Empowerment

o Choice

- Cultural Considerations
- Agree a HIPS wide 'Organisation Self Assessment Framework' which seeks to give guidance on what it means to be a Trauma Informed Organisation.
- Agree an insert for contracts and grants to support the inclusion of Trauma Informed in commissioning, and be more explicit about the role of Trauma Informed in plans / strategies.
- Deliver a rehabilitation programme for high negative impact offenders. Appendix

Through the VRU, four large interventions have been commissioned which target knife crime through increasing evidence-based protective factors and decreasing evidence-based risk factors for involvement in violence:

- Choices Schools-based social skills and problem solving programme of workshops for children in the vulnerable transition from year six to year seven.
- A&E Navigators An intervention which involves youth workers being present in five A&E departments. They offer support to under 25 year olds whilst in hospital and through social prescribing in the community.
- Trauma Informed Practitioners (TIPs) An innovative intervention in which TIPs patrol with District Police Teams in Waterlooville. This is based on a pilot previously delivered in Hampshire which was positively received.
- RESET A voluntary custody intervention for 18-25 year olds which involves navigators supporting offenders whilst in custody and within the community to divert them from criminality and towards education, training or employment.

- During the development of RESET, the VRU Manager communicated with other VRUs to learn about their custodybased navigators interventions to understand good practice and obstacles encountered.
- During the development of Choices, the VRU worked with the commissioned provider to ensure that learning was considered from South Yorkshire's VRUs research captured in their Guidelines for Evidence-Based Knife Education.
- The VRU is part of a national network who regularly communicate to share good practice regarding any aspect of violence reduction, often via the online service Basecamp which makes it possible to communicate with the entire network.

- VRU colleagues attend regular meetings to discuss evaluation of custody-based navigator interventions. This gives opportunities to learn from other areas' evaluations to increase the robustness of our local monitoring and evaluation.
- VRU colleagues attend, and now chair, the National VRU
 Learning and Evaluation Network which discuss all aspects of
 evaluation violence reduction. This has supported the
 development of the Outcomes Based Performance Framework
 as the VRU has incorporated positive features of other VRU
 frameworks into our own.
- Liverpool John Moores University have evaluated similar intervention styles previously, in particular Trauma Informed training, A&E Navigators, Custody-Based Navigators, and different schools-based interventions. They are constantly referencing and drawing on the expertise gained from these experiences to deliver strong evaluations for our VRU.
