1. The decision:

That the Director of Children's Services approves the award of grants to:

1.1 The Greenery Nursery School, the sum of £4,500

The Greenery Nursery School is recommended for an award of £4,500 from the Childcare Sustainability Grant to contribute towards ongoing salary and business costs to support the setting while it experiences the slow return of families following the COVID pandemic. The Greenery Nursery School is a new provider which took over an existing setting in January 2020. The Greenery has been ineligible for most COVID relief packages due to the business being new. The provider has requested this additional funding to help ensure continued early years education and childcare for local families in the rural Swanmore area and broader Meon Valley.

- 1.2 Conditions that will be attached to the grant include the requirements to:
 - i) Complete a business surgery by end of September 2021 with a follow up review of business plan in January 2022.
 - ii) Undertake promotion activities to encourage take up of places.
 - iii) Use the Hempsall's business tools to review their business and develop a business and marketing plan available by end of December 2021.

2. Reasons for the decision:

2.1 The Childcare Sustainability Grant is part of Hampshire County Council's COVID response. A grant fund of up to £365,000 has been made available to childcare providers who require support with short term financial sustainability. On 24/02/2021, the Director of Children's Services, in consultation with the Executive Lead Member, was given the authority to approve awards to providers where it is evidenced there is sufficiency of need and where, without financial support, the provider may be unable to operate.
