1. The decision:

That the Director of Children's Services approves the awards:

- Chawton Pre School £3950
- Fairlands Nursery £3000
- Mulberry Pre School £4,999
- The Village Pre School £4,000
- 1.2 The Childcare Sustainability Grant will be used to contribute towards registration requirements, marketing and staffing costs. These settings are needed to provide sufficient places and support continued early years education and childcare for families in Hampshire. These providers will be required to continue to review their business planning and undertake regular business reviews by attending regular CDBO business surgeries commencing Jan 23.

Chawton Pre-School is the only setting in the rural village of Chawton, it is experiencing low numbers of children, however there is an increase in housing developments locally and this setting will help to support further demand as the housing develops. The grant will provide support to budget and cashflow challenges.

Fairlands Nursery supports a semi-rural community. New ownership and the challenges of Covid has resulted in significant cash flow challenges, the grant will help support a period of change from a restricted term time only to a full day care offer.

Mulberry Pre-School supports a significant number of service families and the setting has commenced its journey to make changes to the model of delivery and they have increased marketing on social media platforms. The grant will provide support to budget and cashflow

The Village Pre School supports a village community and in the past year

had to relocate the setting to a neighbouring village. The grant will support cashflow challenges as the new venue is marketed and becomes more established.

2. Reasons for the decision:

2.1 The Childcare Sustainability Grant is part of Hampshire County Council's COVID response. A grant fund of up to £209,000 has been made available to childcare providers who require support with short term financial sustainability. On 24 February 2021, the Director of Children's Services, in consultation with the Executive Lead Member, was given the authority to approve awards to providers where it is evidenced there is sufficiency of need and where, without financial support, the provider may be unable to operate.
