#### THE CONTEXT

Government grant at same Level as 2017/18

Flexibility to PCCs in England to increase their Band D precept by up to £12 per year (£1 per month for a typical Band D household) in 2018/19

PCCs and Chief Constables must commit to further efficiencies and modernisation

### CONSULTATION RESULTS

#### Survey:

- 3,981 People completed online survey
- 70% indicated they would be willing to pay more council tax
- Of those who expressed a preference for a specific increase 75.3% said they would be willing to pay £10 or more

#### Consultation days:

- 119 people attended
- 86% said would be willing to pay £12
