### 1. The decision:

- 1.1 This is a proposal for the dedication of public footpath rights in Bighton, under Section 25 Highway Act 1980. The proposed footpath runs north-east of the definitive line of Bighton Footpath 717.
- 1.2 It is also proposed that authority is given for an extinguishment order to be made under section 118 of the Highways Act 1980 for that part of the definitive line of Footpath 717 that will no longer be needed for public use as a result of the dedication.
- 1.3 Both the dedication route and the proposed extinguishment are shown on the accompanying plan. Both proposals result from an application received from one of the property owners which the route crosses.

# 2. Reason(s) for the decision:

- 2.1 The line of the route subject to the dedication runs adjacent to the definitive line of Bighton Footpath 717. The path width varies between 1.10 and 2.10 metres with pinch points at SU 6304 3304 and SU 6300 3309, SU 6295 3314 and SU 6292 3322. This has been used by the public for a significant period of time, in place of the definitive line of Footpath 717, which has created a long-standing anomaly on the Definitive Map. Dedicating the new route will enable this anomaly to be resolved.
- 2.2 It is recommended that the dedication be accepted. The dedication can then be followed by a Public Path Order under Section 118 Highways Act 1980 to extinguish the part of the definitive line of Footpath 717 that is no longer needed for public use.

- 3. Background
- 3.1 The landowners have agreed to dedicate the route which has been preferred by users over the years, part of the definitive route which is not used can then be extinguished once this is complete.
- 3.2 There are three landowners who have consented to this application being processed.
