## 1. The decision:

1.1 This is a proposal for the dedication of a public footpath with cycling rights in Dummer, under common law. The proposed footpath runs east of the definitive line of part Dummer Footpath 7.

# 2. Reason(s) for the decision:

- 2.1 Hampshire County Council proposes to enter into a creation agreement with Bellway Homes Limited (Wessex) under common law to record a public footpath with cycling rights along Longwood Copse Lane to a junction with Beggarwood Lane, in Dummer, near Basingstoke.
- 2.2 The route, which was constructed as part of works to build an access road to the new development, is already on the ground and in use. It is proposed that, in due course, that part of Dummer Footpath 7 that runs down the middle of this access road, is extinguished under the provisions of Section 118 of the Highways Act 1980, as the route will no longer be needed for public use as a consequence of the above-mentioned creation.
- 2.3 The dedication route is shown on the accompanying plan.

## 3. Legal Framework:

3.1 Creation of footpath, bridleway or restricted byway by agreement.

A local authority may enter into an agreement with any person having the necessary power in that behalf for the dedication by that person of a footpath, bridleway or restricted byway over land in their area.

An agreement under this section is referred to in this Act as a "public path creation agreement".

# 4. Background

- 4.1 The proposal is a result of a recent housing development on Longwood Copse Lane in Dummer. Hampshire County Council proposes to enter into a creation agreement with Bellway Homes Limited (Wessex) under common law to record a public footpath with cycling rights along the newly constructed footway of Longwood Copse Lane which terminates at a junction with Beggarwood Lane (as shown on the attached map). The route is already on the ground and in use.
