1. The decision:

- 1.1. That authority is given to extinguish Footpaths 34, 35, and 37 in the parish of Corhampton and Meonstoke.

2. Reason(s) for the decision:

- 2.1. The Hampshire (City of Winchester No.46) (Parish of Corhampton and Meonstoke and Parish of Droxford) Definitive Map Modification Order 2019 (“Order No.46”) was made and confirmed earlier this year which added footpaths 504 and 505 in the parish of Corhampton and Meonstoke.
- 2.2 Corhampton and Meonstoke Footpath 505 was added to the map as Footpath 37 had never been used by the public. It is now expedient that Footpath 37 should be stopped-up because it is not needed for public use.
- 2.3 Footpath 34 and 35 form spurs from Droxford Footpath 1 to the B3035 Corhampton Road, however these routes have also not been used for many years and a through route has now been provided by Footpath 504. It is now expedient that Footpaths 34 and 35 should be stopped-up because it is not needed for public use.
- 2.4 The Ramblers, Open Spaces Society, Landowners, and relevant local councils have been consulted and no objections have been raised to the proposed extinguishments.

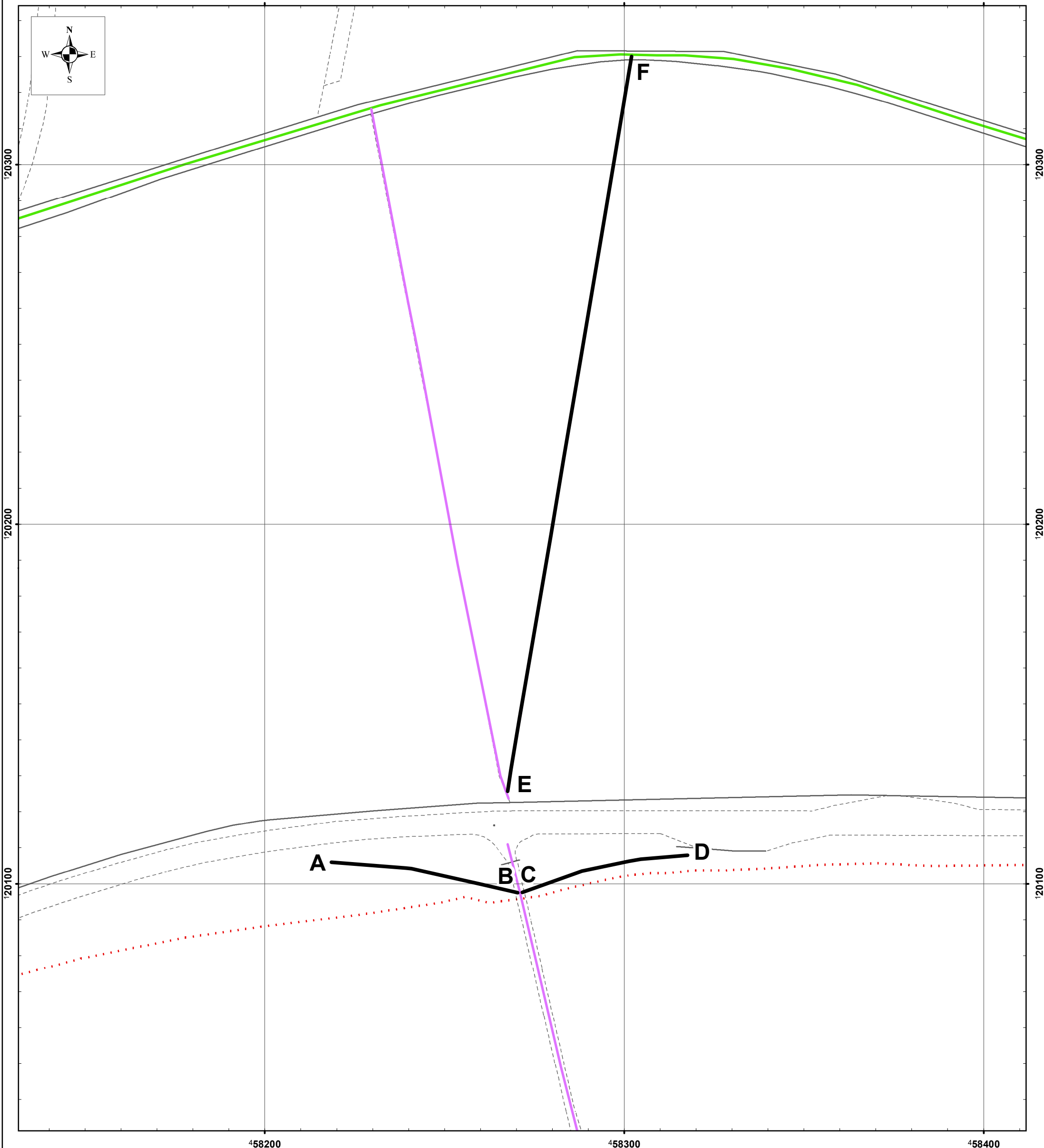
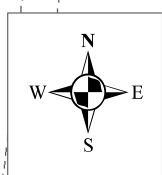
