Title:	Traffic Order Proposals – Burnetts Lane Area, Horton Heath – Amendments to Speed Limits

1. The decision:

1.1. That a traffic order be implemented under the Road Traffic Regulation Act 1984 (RTRA), the effects of which will be to impose new and vary existing speed limits to accommodate the construction of a new roundabout as follows:

(1) 20mph

(i) The unnamed access road, between a point 29 metres southwest of the U520 Burnetts Lane Roundabout to the gated entrance to Chalcroft Business Park, an approximate distance of 76 metres.

(2) 40mph

- (i) The unnamed access road for Chalcroft Business Park from its southwest junction with the U520 Burnetts Lane Roundabout for an approximate distance of 29 metres.
- (ii) U520 Burnett's Lane between a point 92 metres south-west of its junction with Barley Fields, to the junction of the U520 Burnetts Lane Roundabout an approximate distance of 712 metres.
- (iii) U520 Burnett's Lane between its junction with C42 Moorgreen Road and C42 Bubb Lane and a point at the northern kerb of the previously mentioned unnamed access road to Chalcroft Business Park, an approximate distance of 855 metres.
- (iv) The entire length of the circulatory carriageway of the U520 Burnetts Lane Roundabout.
- (v) The unnamed link road between its junction with U520 Burnetts Lane and B3342 Bubb Lane Roundabouts, an approximate distance of 444 metres.
- (vi) U3342 Bubb Lane Roundabout from its junction with B3342 Tollbar Way and a point in line with the centre line of C42 Bubb Lane to its western junction of the B3342 Bubb Lane Roundabout an approximate distance of 185 metres.

- (vii) The entire length of the circulatory carriageway of the B3342 Bubb Lane Roundabout.
- (viii) B3342 Bubb Lane between the north-eastern junction of the B3342 Bubb Lane Roundabout and a point 143 metres North-east thereof.

(3) 50mph

(i) B3342 Bubb Lane between a point 143 metres north-east of its junction with B3342 Bubb Lane roundabout and its junction with the Denham's Corner Roundabout, an approximate distance of 619 metres.

2. Reasons for the decision:

- 2.1. Following the continuing development of Horton Heath, the developer is constructing a roundabout along B3342 Bubb Lane just north of C42 Bubb Lane that will then link up with the U520 Burnetts Lane. When constructed the speed limit along this new road will be identical to B3342 Bubb Lane. In the interest of safety, the current 40/50 terminal along the B3342 Bubb Lane will be relocated north of the roundabout in line with the first 50mph repeater signs and will then remain 50mph to the roundabout that joins the B3354 Winchester Road and C42 Snakemoor Lane.
- 2.2. No objections or representations were received in response to the public consultation which took place between 24th September and 15th October 2021.
- 2.3. Due consideration has been given to RTRA 1984 sections 122(1) and 122(2) and any other relevant legislation. In this case the Decision Maker acting on behalf of the Local Authority considers this TRO expeditious, for the convenient and safe movement of vehicular and other traffic (including pedestrians).
- 2.4 The decision outlined in paragraph 2.3 (above) to exercise the functions of the Local Authority under RTRA 1984 sections 122(1) and 122(2) has been reached on the basis of what is reasonably practicable.
